Please title the email 'ERC Residents EV Discount Tariff Application - [REPLACE WITH APPLICANT'S NAME]'. Residents with access to dedicated off-street parking within the curtilage of their property (i.e. a private driveway or garage) will not be eligible for the concession.

Residents with access to a shared residential parking area (e.g. within a flatted development), but without a dedicated parking space would be eligible for the discount. Residents with dedicated parking not within the curtilage of their property (such as a remote garage, or dedicated parking space within a shared residential parking area) may be eligible for the concession, though this will be assessed on a case-by-case basis.

Please note:

1. If information submitted to obtain the discounted electric vehicle charging rate for yourself or others is found to be fraudulent, the request application will be rescinded and the Council may pass the matter to the Procurator Fiscal's Office.
2. This discount tariff scheme only applies to East Renfrewshire Council's owned publicly accessible electric vehicle chargers.
3. This discount tariff is subject to change. Any changes will be made public via East Renfrewshire Council's and ChargePlace Scotland's Website.
