# **Keeping People Safe in East Renfrewshire**

### Introduction



As Local Police Commander for East Renfrewshire, I am pleased to provide this report which relates to our performance and policing priorities for Q3 of the financial year 2024-25. The information contained within this report allows us to provide an overview of the impacts on policing and how we have performed during this third quarter.

This period sees temperatures drop, our days shorten, and an inevitable increase in indoor incidents. Demands on policing are varied and during this period we have assisted the public and our partners in several areas including the lead up to Bonfire night and with our Festive Action Plan.

Whilst many people head indoors during this period, we also supported the successful and safe outdoors fireworks event in Giffnock which brings over 5000 people to the area. I want to thank East Renfrewshire Council for their support and leadership in ensuring this was safe and secure event for everyone in attendance.

I also want to welcome Chief Inspector Gillian Faulds as the new Local Area Commander for East Renfrewshire. Gillian brings with her a wealth of experience from her years of dedication and service within policing. Gillian is replacing now temporary Superintendent Graeme Gallie who served as the Local Area Commander for just over 2 years. I want to thank Graeme for his dedication to the role and wish him well with his promotion.

This report will bring to life how we have managed to balance our resourcing against demand whilst tackling the priorities of the communities in East Renfrewshire.

### **Public Protection**

The total number of sexual crimes recorded for this quarter are 116, this is an increase of 24 offences compared to the same period last year. We have successfully detected 45% of sexual crimes this quarter.

Whilst we know that reporting of sexual crimes is still on the rise nationally, it is important to note that many of these offences are non-recent and are only now being reported to police. It is encouraging to see that the continual work to raise awareness both locally and nationally (16 days of Activism against Gender-based Violence) has had a positive impact on survivors to feel confident about coming forward to report.

#### Local Policing Priority: Crime (Sexual Offences)

Domestic incidents have increased this period. This has resulted in 456 incidents which is an increase of 10% compared to the same period last year. 60% of these incidents were non-criminal in nature, as a result there were 182 criminal domestic incidents recorded. These incidents have resulted in 266 offences of which 162 were successfully detected.

### **Acquisitive Crime**

I am pleased to report that reported Housebreakings and Attempt Housebreakings offences have continued to drop throughout this period. There has been a 46% reduction across the 5 year average. This equates to a reduction of 45 offences compared to the 5 year average of 98.

This year the total number of Motor Vehicle Crimes remains similar to the 5 year average, with a total of 82 offences in comparison to the average of 81. However, over that period there has been a reduction in Theft from a Motor Vehicle and Theft of a Motor Vehicle.

Our community policing team continue to highlight and promote ways to improve property and vehicle safety.

### Local Policing Priority: Crime (Crimes of Dishonesty)

Fairer East Ren Plan: Reducing social isolation, loneliness & increasing safety

This quarter we have seen a slight increase in the overall Crimes of Dishonesty, whilst we have seen positive impacts on Housebreakings and Motor Vehicle Crime we continue to see the upward national trend in Theft by Shoplifting and Common Theft offences being mirrored in East Renfrewshire.

To date 229 Thefts by Shoplifting have been reported, which is up 30% compared to this this time last year, however down 8% on the last quarter. Our community officers continue to work closely with partners and retailers resulting in 80 detections this year so far.

Whilst Fraud offences are still on the rise across Scotland, I am pleased to report that we continue to maintain our reduction in fraud offences with a 15% reduction in offences compared to last year. This equates to 132 offences compared to 156 for the same period last year and reflects the good work implemented by the Local Policing Team to provide educational inputs to the community to stay alert to frauds and scams.

### **Violent Crime**

Local Policing Priority: Crime (Violent Crime; Disorder & Antisocial behaviour)

Fairer East Ren Plan: Reducing social isolation, loneliness & increasing safety

There has been 431 Non-Sexual Crimes of Violence recorded so for this year. This is an increase of 7% over the 5 year average.

Robbery (including assault with intent to rob) has reduced by 33% with 8 being recorded this year. We have also seen a 12% reduction of Serious Assaults in this period, with 14 being recorded.

Common Assaults have increased by 27 compared to last year bringing this year's total to 327.

### **Anti-social behaviour & Disorder**

This quarter we continue to see a 6% reduction in complaints regarding Disorder, with a total of 1293 complaints recorded to date.

Over the last quarter 21 Hate Crimes were reported. 71% of these were detected and 28% of those were juvenile offenders. There is no trend and they are split across homophobic, racial, transgender and disablist.

#### Local Policing Priority—Crime (Disorder & Antisocial behaviour

Fairer East Ren Plan—Reducing social isolation, loneliness & increasing safety

We continue to work with our partners to reduce anti-social behaviour that blights communities. Vandalisms have increased slightly compared to last year with a further 4 incidents recorded. With the support of partnership working with the SFRS, Fire raisings are 36% down compared to last year.

Culpable and Reckless conduct has also reduced significantly and is down 27% compared to last year with 27 offences being recorded.

During this quarter, officers carried out enquiries into 22 Missing Persons reports, 14 of which were adults, 2 adults cared for and 6 children. Their ages ranged between 10-69 years old. All persons were traced safe and well. We utilised a total of 2300 police resourcing hours in efforts to trace these missing persons. 6 were graded high risk, 16 medium risk and 0 low risk.

### **Drug Dealing & Use**

Local Policing Priority: Crime (Drug Supply & Manufacture)

Fairer East Ren Plan: Reducing social isolation, loneliness & increasing safety

Detecting Drug offences across East Renfrewshire is a result of proactive policing and community support. I am pleased to report that we have recorded 102 offences of Drug possession this year. We will continue to deploy uniformed and plain clothes officers to target areas of greatest concern whilst working with our partners to tackle the public health concerns around drugs.

#### Our Area of Focus: Violent Crime

In November, a 14 year old male was robbed within local public park in the Newton Mearns area. An extensive enquiry was carried out by our Community Investigation Department and Community Policing Team and an 18 year old male was arrested and charged.

During this quarter, police received a report of a male in a street in Barrhead in possession of a machete. Officers traced the male and were required to use their officer safety equipment. A 32 year old male was arrested and charged for being in possession of a knife and for threatening and abusive behaviour towards officers.

#### Our Area of Focus: Drug Supply and Manufacture

Within East Renfrewshire we are committed to targeting drug supply and misuse. During this quarter, officers acting upon intelligence, carried out a search of a premises under warrant in the Barrhead area. A large cannabis cultivation was found within. A 53 year old male was arrested, interviewed and charged with being involved in the control and supply of drugs.

Local officers continue to carry our proactive patrols in the East Renfrewshire area, in December local community officers stopped and searched an 18 year old male in the Clarkston area who was found to be in possession of a Class B drug. He was issued with a recorded police warning.

#### Our Area of Focus: Crimes of Dishonesty

In November police were made aware of 2 masked males within a vehicle acting suspicious in the Newton Mearns area. Police attended immediately and traced the males. Officers carried out enquires within the surrounding area. Two males aged 42 and 19 were charged with various road traffic offences and for being in the curtilage of premises with intention to commit theft. They were held custody to appear at court the next day.

In December Local Community Officers were carrying out Festive Action plan patrols in Barrhead Main Street when they were alerted to a male acting suspiciously within a local shop. Officers swift actions resulted in a 38 year old male being arrested and charged for shoplifting.

### PROTECTING VULNERABLE PEOPLE

#### Our Area of Focus: Vulnerable Road Users

Keeping all road users safe remains a priority for officers within East Renfrewshire. We continue to work with all our partners to target those who cause harm to our roads and networks. Local officers continue to carry out proactive vehicle stop checks, within this quarter over 20 motorists have been charged with having no MOT and over 30 charged with driving with no insurance.

In November we received reports of a car driving in a dangerous manner, officers traced and stopped the vehicle within the Thornliebank area. Within the vehicle they observed nitrous oxide canisters, balloons and cannabis. The driver was subject to a drugs swipe which tested positive. A 19 year old male was arrested and reported for driving under the influence of drugs.

#### Our Area of Focus: Domestic Abuse - Adult Protection - Child Protection

Domestic Abuse and harm remain a priority for Police Scotland. During this quarter we worked closely with our partners to encourage action and awareness against all forms of violence against women and girls. Local officers took part in the 16 days of Activism. As part of this campaign, officers in East Renfrewshire engaged in webinar sessions and delivered 'You, Me, Together' inputs to young persons within schools.

In November a 33 year old male was traced hiding in a cupboard and arrested after failing to adhere to his domestic bail conditions set by the court not to be in the presence of the domestic abuse survivor. He was charged and held custody to appear at court the next day.

### Our Area of Focus: Young People

In this quarter our campus officers continued to work closely and build excellent relationships with the school communities. They secured additional funding which allowed them to deliver the October week wellbeing programme for the second year in a row. The programme has been very successful in assisting some of the most vulnerable young persons in our local community.

In addition, our campus officers have been busy delivering bespoke inputs to secondary schools across East Renfrewshire. In particular, on the lead up to Fireworks night our officers delivered inputs highlighting the dangers of fireworks and associated offences.

#### CONCLUSION

As the Local Policing Commander for East Renfrewshire, I am pleased to present the Cabinet Report for the 3rd Quarter of the year 2024/25.

As outlined in this Cabinet Report, we have successfully navigated the demands and intricacies of keeping the people of East Renfrewshire safe. This can only be done with the support of our partners and the public. I look forward to building on this successful approach as we move forward through 2025.

## **Local Fire and Rescue Service Plan Priorities**

The Local Fire and Rescue Service Plan has been developed to set out the priorities and objectives within East Renfrewshire and allows our local authority partners to scrutinise the performance outcomes of these priorities. We will continue to work closely with our partners in East Renfrewshire to ensure we are all "Working Together for a Safer Scotland" through targeting risks to our communities at a local level.

The plan has been developed to complement key partnership activity embedded across East Renfrewshire Community Plan and associated Delivery and Thematic plans. Through partnership working we will seek to deliver continuous improvement in our performance and effective service delivery in our area of operations.

The Local Fire and Rescue Plan for East Renfrewshire identified six areas for demand reduction and is subject to regular monitoring and reporting through the Police / Fire and Rescue Committee. A summary of the priorities and current activity is detailed below with further detail and analysis contained within this performance report.


### **Activity by Time of Day**



### Top 15 Incidents Types by %















### **Accidental Dwelling Fires Casualties**




### **Accidental Dwelling Fire Casualties by Ward (% share)**












<u>Primary Fires</u> - all fires in buildings, vehicles and outdoor structures or any fire involving casualties, rescues or fires attended by five or more appliances

<u>Secondary Fires</u> - fire incidents that did not occur at a primary location, was not a chimney fire in an occupied building, did not involve casualties (otherwise categorised as a primary incident) and was attended by four or fewer appliances.

### **Primary Fire Ratio by Activity Type**










## **Secondary Fire Ratio by Activity Type**



### **Deliberate Fires Compared to Operational Activity**














### **Unwanted Fire Alarm Signals**




### **Unwanted Fire Alarm Signals by Ward (% share)**





### **Unwanted Fire Alarm Signals Activity Ratios**




**UFAS Percentage Against all False Alarms**
