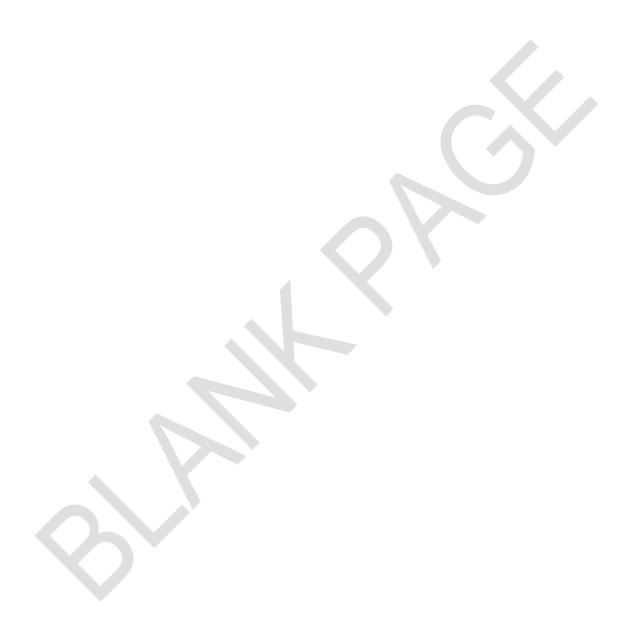

CIVIC HOSPITALITY COSTS AND USE OF COUNCIL ACCOMMODATION

PURPOSE OF REPORT

1. To advise the committee of the costs of various recurring civic events, the current estimated level of funding available for new events, and extent to which, under delegated powers, authority has been granted to outside bodies to use Council accommodation for meetings and functions which fall outwith the letting arrangements managed by other departments.

RECOMMENDATION

2. That the committee notes the report.

CIVIC HOSPITALITY COSTS

- 3. On 26 June 2013 the Council approved the establishment of a Civic Hospitality Committee responsible for all civic hospitality matters on behalf of the Council including the:-
 - consideration and determination of all requests for the provision of civic hospitality by the Council with an estimated cost of over £400:
 - consideration and determination of any proposed new Council events to be funded from the civic hospitality budget; and
 - consideration and approval of all protocols and procedures associated with civic hospitality.
- 4. The 2019/20 budget for civic hospitality is £18,000 as in 2018/19. As well as being used to fund events organised in response to external requests for civic hospitality, the decision was taken that those annual events organised by the Council such as the Holocaust event, Remembrance and the Senior Citizens' Concerts for example, are to be funded from this budget.
- 5. As was the case prior to the establishment of the committee, all requests with an estimated value of less than £400 are continuing to be dealt with through delegated powers, subject to consultation taking place with the Provost and Deputy Provost. Proposals for the introduction of any additional Council hosted events to be funded from the civic hospitality budget, either on a one-off or recurring basis, are now submitted to the committee for consideration. Examples of other things also funded from this budget are the costs of attendance at any charity events such as dinners, the costs associated with school debates and the purchase of flowers for those known to be celebrating a special wedding anniversary or birthday (e.g. 100th birthday, diamond wedding anniversary etc.) in East Renfrewshire.

6. As part of the new arrangements it was agreed that at the start of each year the committee would be provided with the details of the recurring events referred to above and associated indicative costs, as well as the amount of funding remaining for civic hospitality requests. A copy of the relevant information is attached (see Appendix 1). The costs provided are largely estimates based on expenditure incurred in 2018/19 given that many of the detailed arrangements for forthcoming events remain to be discussed and finalised. Based on current expenditure estimates, the funding left in the 2019/20 budget to deal with new requests for civic hospitality is currently approximately £8,555.

USE OF COUNCIL ACCOMMODATION GRANTED UNDER DELEGATED POWERS

7. In terms of the Council's Scheme of Delegated Functions, the Deputy Chief Executive or Democratic Services Manager are authorised to grant the use of Council accommodation to outside bodies for the purpose of holding meetings and functions etc. which fall outwith the letting arrangements managed by other departments. It was agreed that, under the new arrangements, the committee would be provided with details of all requests granted in terms of these delegated powers. Since the last update on this was submitted to the committee in April 2018, no such requests have been granted.

RECOMMENDATION

8. That the committee notes the report.

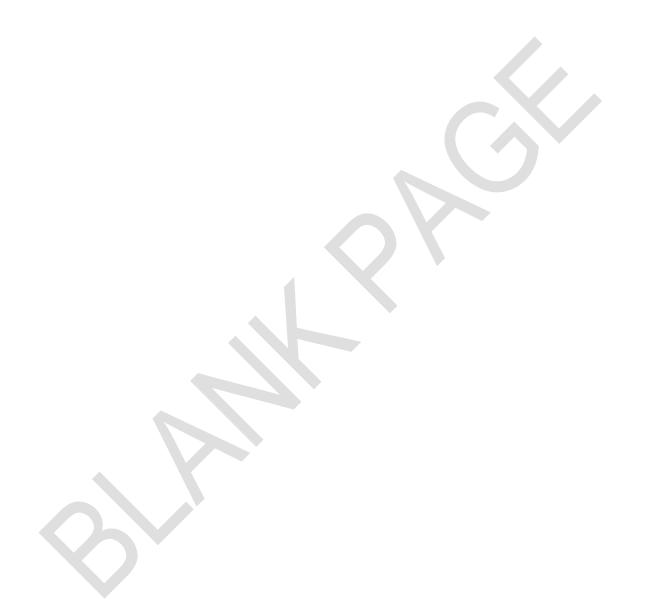

REQUESTS FOR CIVIC HOSPITALITY - VARIOUS

PURPOSE OF REPORT

1. To consider requests for the Council to host four civic receptions at one of which Queen's Awards for Voluntary Service (QAVS) would be presented to the Include Me 2 Club and also the East Renfrewshire Additional Support Needs (ASN) Parents Action Group, the others being to recognise the 175th Anniversary of the United Reformed Church, Barrhead; the 100th Anniversary of Mearns, Bowling Club, Newton Mearns; and the 125th Anniversary of Giffnock Bowling Club, Giffnock.

RECOMMENDATION

2. That the committee considers the requests referred to in this report and the accompanying Appendices.

BACKGROUND

3. On 26 June 2013 the Council agreed to establish a Civic Hospitality Committee with the following terms of reference:-

To be responsible for all civic hospitality matters on behalf of the Council including the:-

- consideration and determination of all requests for the provision of civic hospitality by the Council with an estimated cost of over £400;
- consideration and determination of any proposed new Council events to be funded from the civic hospitality budget; and
- consideration and approval of all protocols and procedures associated with civic hospitality.

REPORT

4. Four requests for civic hospitality have been received which require to be considered by the Committee in view of the estimated cost of each proposal exceeding £400. Details of the requests and related proposals are set out in the remainder of this report.

QAVS Winners - Include Me 2 Club; and East Renfrewshire Additional Support Needs (ASN) Parents Action Group

5. The QAVS was created to mark the Golden Jubilee in 2002 and recognises outstanding contributions by groups of volunteers. A request to hold a civic reception at which Queen's Awards for Voluntary Service (QAVS) would be presented to the East

Renfrewshire Additional Support Needs (ASN) Parents Action Group and also the Include Me 2 Club, both of which were awarded a QAVS in 2019, has been received from HM Lord-Lieutenant of Renfrewshire. The East Renfrewshire ASN Parents Action Group has been awarded its QAVS for supporting families and young people with additional support needs. The Include Me 2 Club has been recognised for its work with people of all ages with additional support needs and disabilities to create inclusive communities. Members will recall that the operators of the Include Me 2 Club received the Provost's Award in 2018. The Lord-Lieutenant would present the Awards at the proposed event. The details of the proposal are included in Appendix 1 accompanying this report.

United Reformed Church, Barrhead – 175thAnniversary

6. A request to hold a civic reception in celebration of the 175th Anniversary of the United Reformed Church, Barrhead has also been received. The Church wishes to celebrate 175 years of continuous Christian worship which began with the setting up of a congregation in June 1844. The details of the proposal are included in Appendix 2 accompanying this report.

100th Anniversary of Mearns Bowling Club, Newton Mearns; and 125th Anniversary of Giffnock Bowling Club

7. Requests to hold civic receptions in celebration of the 100th Anniversary of Mearns Bowling Club; and the 125th Anniversary of Giffnock Bowling Club have also been received. The centenary of Mearns Bowling Club is considered to be a very important occasion for everyone associated with the Club, namely the Members and wider local community who are welcomed and use its facilities. Similarly, Giffnock Bowling Club is proud of the leisure and social facility it offers in East Renfrewshire. The event would complement other events the Club is planning for businesses, local residents and club members. Details of the proposals for these events, which would take place during the 2020/21 financial year, are included in Appendices 3 and 4 accompanying this report.

BUDGET

- 8. At £18,000 the 2019/20 budget for civic hospitality is the same as in 2018/19. As well as being used to fund events organised in response to external requests for civic hospitality, the decision was taken previously that those annual events organised by the Council such as the Holocaust event, Remembrance and the Senior Citizens' Concerts, are to be funded from this budget. Examples of other things also funded from this budget are the costs of attendance at various charity events on approval of requests such as fundraising dinners; the costs associated with school debates; and the purchase of flowers for those known to be celebrating a special wedding anniversary or birthday (e.g. 100th birthday, diamond wedding anniversary etc.).
- 9 When the costs of these additional matters are taken into account, the amount of funding remaining in the 2019/20 budget to deal with new requests for civic hospitality is currently estimated to be £8,555. If the proposals for the QAVS presentations and United Reformed Church are approved at a total estimated cost of £1,506, the balance remaining in the 2019/20 budget is currently estimated to be £7,049.
- 10. The committee is being asked to consider the requests from Mearns Bowling Club and Giffnock Bowling Club for events that would take place in in April 2020, early in the 2020/21 financial year. As such these events would be funded from the 2020/21 budget. However this will not be confirmed until the budget meeting in February next year. This would give both clubs as well as Council officers unreasonably short notice to prepare for and arrange the events. In view of this it is recommended that the committee consider both

applications on the assumption that sufficient funding will be made available through the budget process. As always happens on an annual basis, a report will be submitted to the committee after the start of the financial year estimating the cost of expenditure that is already committed for events, annual and otherwise. It is expected that there will be sufficient funds in the 2020/21 budget for the civic receptions requested.

RECOMMENDATION

11. It is recommended that the committee considers the requests referred to in this report and the accompanying Appendices.

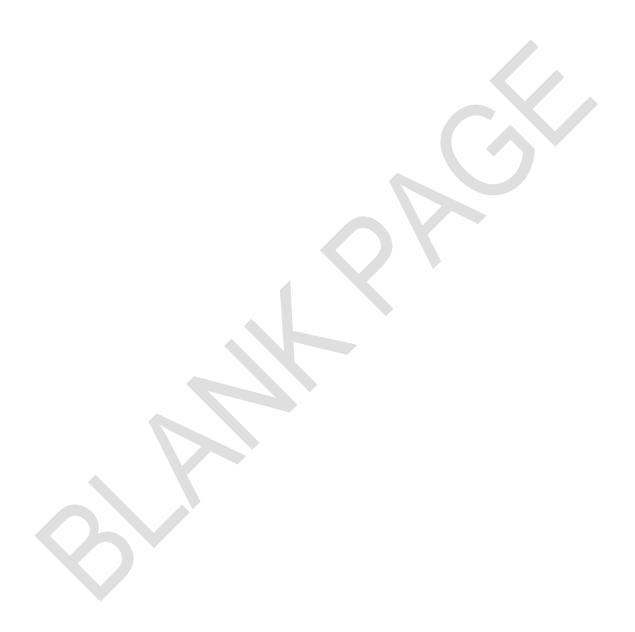

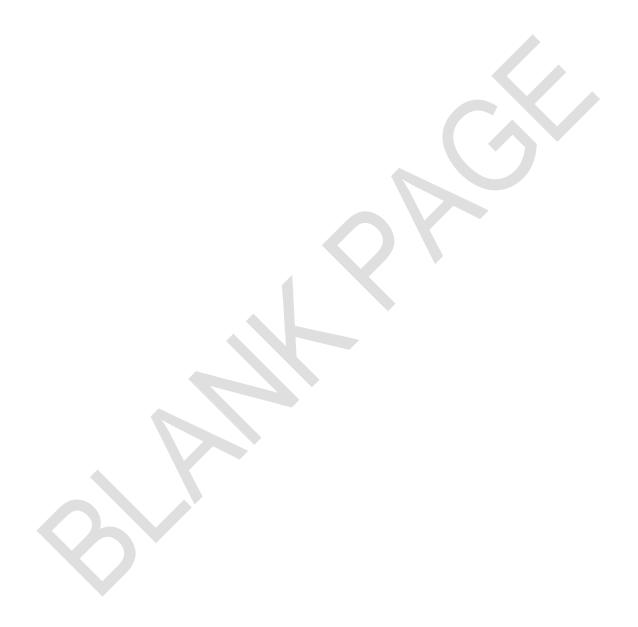

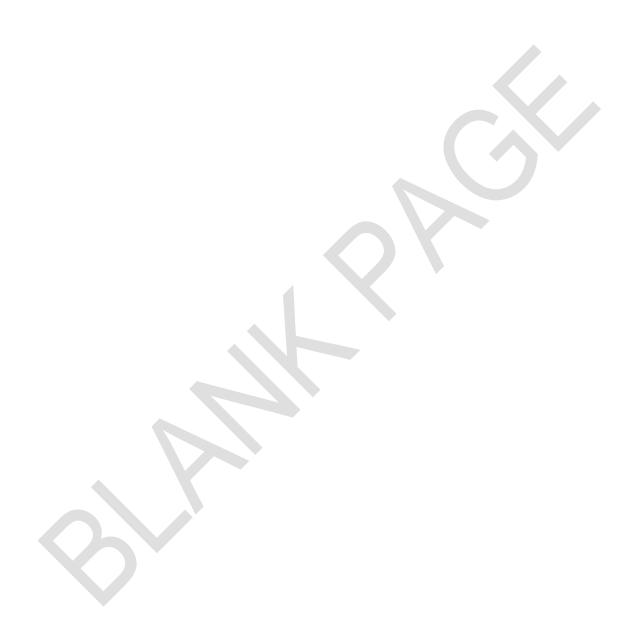
