#### **Preamble & Definitions**

The East Renfrewshire Council in exercise of the powers conferred on them by Sections 1(1), 2(1) to (3) Section 32 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

- 1. This Order may be cited as "The East Renfrewshire Council (Clarkston and Busby Area) (On-Street) (Waiting and Loading) Order 2014" and shall come into operation on 13th November 2014.
- 2. In this order the following expressions have the meanings hereby assigned to them:-

"vehicle", unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power;

"taxi" has the same meaning as in Section 23(1) of the Civic Government (Scotland) Act 1982;

"disabled person's badge" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002;

"disabled person's vehicle" means a vehicle lawfully displaying a disabled person's badge in the relevant position;

"relevant position" has the same meaning as in Regulation 3 of the Local Authorities Traffic Orders (Exemptions for Disabled Person's) (Scotland) Regulations 2002;

"emergency service vehicle" means a vehicle being used by the police, fire brigade or ambulance services;

"local authority" means East Renfrewshire Council;

"Council" means the East Renfrewshire Council;

"parking bay" means a space in a parking place which is provided for the leaving of a vehicle and is appropriately signed as per the Traffic Signs Regulations and General Directions 2002;

"parking attendant" has the same meaning as in Section 63A of the Road Traffic Regulation Act 1984

"universal postal service provider" has the same meaning as in Part 3 of the Postal Services Act 2011;

"universal postal service" shall be construed in accordance with Part 3 of the Postal Services Act 2011;

"load" means to wait for the purpose of placing or removing any object of any description into or from a vehicle;

#### Note:

- (i) All words importing the singular also include the plural and vice versa where the context requires.
- (ii) Except where the context otherwise requires, references to any enactment include any such enactment as amended, extended or applied or re-enacted by or under any other enactment for the time being in force. Enactment means orders, rules, regulations, directions, bylaws and other instruments made or to be made, issued or given under any Act or deriving validity therefrom.
- (iii) All signs, carriageway markings etc shall comply with the Traffic Signs Regulations and General Directions 2002.

#### Section 1: No waiting and No Loading at any time

#### For the lengths of road listed in Schedule 1 there is no waiting and no loading at any time.

- 1/01 Save as provided in Articles 1/02, of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform cause or permit any vehicle to wait or load at any time in any of the lengths of road specified in Schedule 1 to this Order.
- 1/02 Nothing in Article 1/01 of this Order shall:
  - (a) prevent any person from causing or permitting a vehicle to wait or load in any of the lengths of road referred to in these Articles:-
    - (i) for so long as may be necessary to enable a person together with his/her personal luggage to board or alight from the vehicle;
    - (ii) for so long as may be necessary to enable the vehicle if it cannot be conveniently used for such purposes in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the length of the road so referred to, or the laying, erection, alteration or repair in or near to any of the said length of the road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus, as defined in the Telecommunications Act, 1984;
    - (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, to enable the vehicle to be used in connection with police, fire brigade and ambulance purposes;
    - (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his/her control or to such waiting being necessary in order to avoid an accident;
    - (v) If the vehicle bearing the livery of a universal postal service provider is in the service of or employed by a universal postal service provider in the course of the provision of a universal postal service and is stationary only for so long as may be reasonably necessary for postal packets to be collected or delivered to or from adjacent premises or posting boxes;
    - (vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of

- furniture from such premises to a depository or to such premises from a depository;
- (vii) to enable the vehicle to be used wholly and necessarily by the principal participants in connection with funeral operations and weddings.
- (b) apply to an emergency service vehicle.

#### Section 2 No Waiting and No Loading During Prescribed Hours

- For the lengths of road listed in Schedule 2 to this Order, the times prescribed for Section 2

  are: No Waiting 8am 6pm Monday to Saturday and No Loading 8am 6pm Monday to

  Saturday
- For the lengths of road listed in Schedule 3 to this Order, the times prescribed for Section 2 are: No Waiting and No Loading 8am 9am and 5pm 6pm Monday to Friday
- For the lengths of road listed in Schedule 6 to this Order, the times prescribed for Section 2 are: No waiting and No loading 8am 9am and 5pm 6pm Monday to Friday
- 2/01 Save as provided in Articles 2/02, 2/03 and 2/04 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform cause or permit any vehicle to wait or load at the times prescribed on any of the lengths of road specified in Schedules 2, 3 and 6 to this Order. The prescribed times for Section 2 are:

For the lengths of road listed in Schedule 2 - no waiting and no loading 8am - 6pm Monday to Saturday inclusive;

For the lengths of road listed in Schedule 3 – no waiting and no loading 8am – 9am and 5pm – 6pm Monday to Friday inclusive;

For the lengths of road listed in Schedule 6 – no waiting and no loading 8am – 9am and 5pm – 6pm Monday to Friday inclusive.

#### 2/02 Nothing in Article 2/01 of this Order shall:

- (a) prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in these Articles:-
  - (i) for so long as may be necessary to enable a person together with his/her personal luggage to board or alight from the vehicle;
  - (ii) for so long as may be necessary to enable the vehicle if it cannot be conveniently used for such purposes in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the length of the road so referred to, or the laying, erection, alteration or repair in or near to any of the said length of the road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus, as defined in the Telecommunications Act, 1984;
  - (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, to

- enable the vehicle to be used in connection with police, fire brigade and ambulance purposes;
- (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his/her control or to such waiting being necessary in order to avoid an accident;
- (v) If the vehicle bearing the livery of a universal postal service provider is in the service of or employed by a universal postal service provider in the course of the provision of a universal postal service and is stationary only for so long as may be reasonably necessary for postal packets to be collected or delivered to or from adjacent premises or posting boxes;
- (vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (vii) to enable the vehicle to be used wholly and necessarily by the principal participants in connection with funeral operations and weddings.
- (b) apply to a licenced taxi waiting in a taxi stance during any period for which that stance has been appointed as a taxi stance by the licensing authority under the Civic Government (Scotland) Act 1982.
- (c) apply to an emergency service vehicle.

#### Section 3: No Waiting During Prescribed Hours

- For the lengths of road listed in Schedule 5 to this Order, the times prescribed for Section 3 are: No Waiting 8am 6pm Monday to Friday
- For the lengths of road listed in Schedule 6 to this Order, the times prescribed for Section 3

  are: No waiting 8am 6pm Monday to Saturday
- 3/01 Save as provided in Articles 3/02, 3/03 and 3/04 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait at the times prescribed on any of the lengths of road specified in Schedules 5 and 6 to this Order. The prescribed times for Section 3 are:

For the lengths of road listed in Schedule 5 – no waiting 8am – 6pm Monday to Friday inclusive;

For the lengths of road listed in Schedule 6 – no waiting 8am – 6pm Monday to Saturday inclusive.

- 3/02 Nothing in Article 3/01 of this Order shall:
  - (a) prevent any person from causing or permitting a vehicle to wait in any of the lengths of road referred to in these Articles :-
    - (i) for so long as may be necessary to enable a person together with his/her personal luggage to board or alight from the vehicle;
    - (ii) for so long as may be necessary to enable the vehicle if it cannot be conveniently used for such purposes in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the length of the road so referred to, or the laying, erection, alteration or repair in or near to any of the said length of the road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus, as defined in the Telecommunications Act, 1984;
    - (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, to enable the vehicle to be used in connection with police, fire brigade and ambulance purposes;
    - (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his/her control or to such waiting being necessary in order to avoid an accident;
    - (v) If the vehicle bearing the livery of a universal service provider is in the service of or employed by a universal service provider in the course of the provision of a universal postal service and is stationary only for so long as

- may be reasonably necessary for postal packets to be collected or delivered to or from adjacent premises or posting boxes;
- (vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (vii) to enable the vehicle to be used wholly and necessarily by the principal participants in connection with funeral operations and weddings.
- (b) apply to a licensed taxi waiting in a taxi stance during any period for which that stance has been appointed as a taxi stance by the licensing authority under the Civic Government (Scotland) Act 1982.
- (c) apply to an emergency service vehicle.
- 3/03 Nothing in Article 3/01 of this Order shall apply to any disabled person's vehicle which is not causing an obstruction and which displays in the relevant position a disabled person's badge and is not waiting when waiting and loading is prohibited by Article 3/04(a) (i) to this Order.
- 3/04 (a) Nothing in Article 3/01 of this Order shall prevent any person from causing or permitting a vehicle to wait in the roads specified for as long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that:
  - (i) For the lengths of road listed in Schedule 6 no vehicle shall wait between the hours of 8am 9am and 5pm 6pm Monday to Friday inclusive;
  - (ii) no vehicle shall wait for longer than a period of 10 minutes in the same place without goods being physically loaded onto or unloaded from the vehicle; and
  - (iii) no vehicle engaged in delivering or collecting goods or merchandise or loading or unloading shall wait for a longer period than thirty minutes in the same place;
  - (b) notwithstanding anything in paragraph (a) of this Article the driver of a vehicle waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform or a parking attendant in uniform whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

#### **Section 4: Limited Waiting During Prescribed Hours**

- For the lengths of road listed in Schedule 3 Waiting limited to 90 minutes no return within 1 hour 9am 5pm Monday to Saturday
- For the lengths of road listed in Schedule 4 Waiting limited to 90 minutes no return within 1 hour 8am 6pm Monday to Friday
- 4/01 Save as provided in Articles 4/03, 4/04 and 4/05 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait between the hours of 9am 5pm Monday to Saturday inclusive in any of the lengths of road specified in Schedule 3 to this Order:
  - (a) for a period longer than 90 minutes; or
  - (b) if a period of less than 60 minutes has elapsed since the last period of waiting of the vehicle in any of the said lengths of roads.
- 4/02 Save as provided in Articles 4/03, 4/04 and 4/05 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or a parking attendant in uniform, cause or permit any vehicle to wait between the hours of 8am 6pm Monday to Friday inclusive in any of the lengths of road specified in Schedule 4 to this Order:
  - (a) for a period longer than 90 minutes; or
  - (b) if a period of less than 60 minutes has elapsed since the last period of waiting of the vehicle in any of the said lengths of roads.
- 4/03 Nothing in Articles 4/01 and 4/02 of this Order shall:
  - (a) prevent any person from causing or permitting a vehicle to wait in any length of the roads referred to in these Articles:-
    - (i) for so long as may be necessary to enable a person to board or alight from the vehicle or to load thereon or unload therefrom his/her personal luggage;
    - (ii) for so long as may be necessary to enable the vehicle if it cannot be conveniently used for such purposes in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the length of the road so referred to, or the laying, erection, alteration or repair in or near to any of the said length of the road, of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telecommunications apparatus, as defined in the Telecommunications Act, 1984;
    - (iii) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in pursuance of statutory powers and duties and in particular, but without prejudice to the generality of the foregoing, to enable the vehicle to be used in connection with police, fire brigade and ambulance purposes;

- (iv) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his/her control or to such waiting being necessary in order to avoid an accident;
- (v) If the vehicle bearing the livery of a universal service provider is in the service of or employed by a universal service provider in the course of the provision of a universal postal service and is stationary only for so long as may be reasonably necessary for postal packets to be collected or delivered to or from adjacent premises or posting boxes;
- (vi) for the purpose of loading or unloading the vehicle while the vehicle is standing at the kerb and is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (vii) to enable the vehicle to be used wholly and necessarily by the principal participants in connection with funeral operations and weddings.
- (b) apply to a licensed taxi waiting in a taxi stance during any period for which that stance has been appointed as a taxi stance by the licensing authority under the Civic Government (Scotland) Act 1982.
- (c) Apply to an emergency service vehicle.
- 4/04 Nothing in Articles 4/01 to 4/03 of this Order shall apply to any disabled person's vehicle which is not causing an obstruction and which displays in the relevant position a disabled person's badge.
- 4/05 Nothing in Articles 4/01 to 4/03 of this Order shall prevent any person from causing or permitting a vehicle to wait in the roads specified :
  - (a) for as long as may be necessary for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle at premises adjoining that road provided that no vehicle engaged in delivering or collecting goods or merchandise or being loaded or unloaded shall wait:
    - no vehicle shall wait for longer than a period of 10 minutes in the same place without goods being physically loaded onto or unloaded from the vehicle;
    - (ii) for a longer period than thirty minutes in the same place; and
  - (b) notwithstanding anything in paragraph (a) of this Article the driver of a vehicle waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle shall move the same on the instruction of a police constable in uniform or a parking attendant in uniform whenever such moving may be reasonably necessary for the purpose of preventing an obstruction.

#### Section 5. Taxi Ranks

- For the lengths of road listed in Schedule 7: No waiting 8am 6pm Monday to Sunday except by licenced taxi
- For the lengths of road listed in Schedule 8: No waiting 8pm 7am Monday to Sunday except by licenced taxi
- 5/01 No person shall except upon the direction of a police constable in uniform or a parking attendant in uniform cause or permit any vehicle other than a taxi to wait at the times prescribed on the lengths of road specified in Schedule 7 and 8 to this Order during which times the lengths of road have been appointed as a taxi stance by the Licensing Authority under the Civic Government (Scotland) Act 1982 or during any other such revised periods of time as may be appointed by the Licensing Authority. The prescribed times for Section 5 are:

For the lengths of road listed in Schedule 7 - no waiting 8am - 6pm Monday to Sunday inclusive except by licenced taxi

For the lengths of road listed in Schedule 8 - no waiting 8pm - 7am Monday to Sunday inclusive except by licenced taxi

#### Section 6. Power to suspend the use of a parking bay

- 6/01 Any person duly authorised by the Council may suspend the use a parking bay or any part thereof whenever it is considered such a suspension is reasonably necessary.
  - (i) For the purposes of facilitating the movement of traffic or its safety;
  - (ii) For the purposes of any building operation, demolition, or excavation in or adjacent to the parking bay or the maintenance, improvement or reconstruction of the parking bay or the laying, erection alteration, removal or repair in or adjacent to the parking bay of any traffic sign, parking ticket machine, sewer, or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunication apparatus as defined in sub-paragraph of Schedule 2 of the Telecommunications Act 1984;
  - (iii) For the convenience of occupiers of premises adjacent to the parking bay on any occasion of the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository;
  - (iv) For the convenience of occupiers of premises adjacent to the parking bay at times of weddings funerals or other special occasions;
  - (v) On any occasion on which it is likely by reason of some special attraction or procession that any street be thronged or obstructed; or
  - (vi) For any other purpose which the Council may from time to time see fit and which has received their prior approval.
- 6/02 Any person suspending the use of a parking bay or any part thereof in accordance with the provisions of paragraph 6/01 of this Article shall thereupon place or cause to be placed in or

adjacent to any part of that parking bay the use of which is suspended a traffic sign indicating that:

- (i) waiting by vehicles is prohibited; or
- (ii) limited waiting during prescribed hours is suspended.
- 6/03 No person shall cause or permit a vehicle to be left in any part of a parking bay during such period as there is in or adjacent to that part of the parking bay a traffic sign placed in pursuance of paragraph 6/02 (i) of this Article:- provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for fire brigade, ambulance or police emergency purposes to be left or any other vehicle to be so left if that vehicle is left with the permission of the Council suspending the use of the parking place or the part thereof in pursuance of paragraph 6/01 of this Article or of a police constable in uniform or a parking attendant in uniform.

#### **Section 7 Orders Revoked**

7/01 Those Orders specified in Schedule 9 to this Order are hereby revoked.
