CALENDAR OF MEETINGS – 2019

PURPOSE OF REPORT

1. To seek approval for the 2019 meetings calendar.

RECOMMENDATION

2. That the Council approve the 2019 meetings calendar.

BACKGROUND

3. In terms of the Council's Standing Orders, it is necessary for the full Council to approve the calendar of meetings of the Council, subject to the ability of committees to revise dates thereafter.

REPORT

- 4. To give Elected Members as much notice as possible of future meeting arrangements, the calendar of meetings is routinely prepared up to 18 months ahead with the calendar for 2018 being approved by the Council in June 2017.
- 5. As usual the proposed calendar takes account of all meetings in respect of which the dates have been determined, but does not take into account those ad-hoc meetings which will be held as and when necessary (e.g. Appeals Committee, Appointments Committee, Planning Pre-determination hearing etc.) and any other special meetings that may be called from time to time.

Council

6. In recent years, due to the late approval of the Scottish Government budget and the subsequent late confirmation of local government funding levels, it has been necessary for the originally scheduled budget meeting to be cancelled and rearranged at relatively short notice. This has caused inconvenience for a number of Elected Members. To deal with this, it is proposed that the scheduled budget meeting take place at the end of February (28 February 2019 at 10am). It is expected that funding levels will have been confirmed before then and so the need for cancelling and rearranging the meeting will be eliminated or at the very least minimised.

Education Committee

7. Every effort has also been made to ensure as far as possible that meetings of the Education Committee are not held on the day of Jewish festivals.

Audit & Scrutiny Committee

8. Discussions have taken place with the Head of Accountancy around the timing of the presentation of the Treasury Management Strategy to the Audit & Scrutiny Committee and the full Council, the draft Annual Accounts to the Audit & Scrutiny Committee and the final Annual Accounts to the Audit & Scrutiny Committee and the Council, and appropriate dates built in to the calendar.
