THE EAST RENFREWSHIRE COUNCIL (DISABLED PERSONS' PARKING PLACES) (ON-STREET PARKING) ORDER 2018

PURPOSE OF REPORT

1. The purpose of the Report is to recommend the Council approve the making and confirmation of "The East Renfrewshire Council (Disabled Persons' Parking Places) (On-Street Parking) Order 2018".

RECOMMENDATIONS

It is recommended that the Council approve the making and confirmation of "The East Renfrewshire Council (Disabled Persons' Parking Places) (On-Street Parking) Order 2018" and delegate to the Director of Environment the implementation of the Order in accordance with the associated statutory procedures.

BACKGROUND

- 3. The Disabled Persons' Parking Places (Scotland) Act 2009 requires Local Authorities in Scotland to designate and control the use of all disabled persons' parking spaces.
- 4. East Renfrewshire Council have a duty under the Disabled Persons' Parking Places (Scotland) Act 2009 to promote the proper use of disabled parking places. 'Advisory' Disabled bays are no longer permitted. Instead, bays initially become temporary disabled parking spaces while the statutory process to promote an order is being undertaken to make it a fineable offence to park in them without displaying a valid blue badge.

REPORT

- 5. The draft Order (attached at Appendix One) complies with the requirements of the 2009 Act. There are designated on-street parking spaces for disabled persons at several locations throughout East Renfrewshire, as set out in the draft Order Schedules. These spaces are for the exclusive use of any vehicle displaying, in an appropriate manner, a valid Blue Badge. The spaces are not allocated to individual properties, drivers or vehicle owners. Any vehicle occupying a designated space and not displaying a valid Blue Badge in accordance with the Blue Badge Scheme in Scotland, risks being issued with a Penalty Charge Notice.
- 6. Consultation on the proposed Order complied with "The Local Authorities' Traffic Orders (Procedure) Scotland Regulations 1999 (and subsequent amendments)". The emergency services and other organisations/persons likely to be affected by any provision in the Orders including all Elected Members were notified of the proposals. In addition, Notices advising of the proposals were published in the 'Glasgow South & Eastwood Extra' and the 'Barrhead News'.

7. The Council did not receive any representations or objections to these proposals.

FINANCE AND EFFICIENCY

- 8. The financial implications of implementing the Traffic Regulation Order will be met from the Parking Account. This is an account held under the terms of the Road Traffic Regulation Act 1984 and it is a requirement under Section 55 of the Road Traffic Regulation Act that the Parking Account income and expenditure are reported annually to the Scottish Government.
- 9. There will be future financial and staffing implications resulting from normal maintenance costs associated with updating/amending the Order and the promotion of new Orders for each new Disabled Persons' Parking Place installed and for the removal of those no longer required. There will be a requirement to renew/refresh lining & signing and update the Parking Attendants' hand held computers on an ongoing basis. Therefore, based on averages from previous years, it is estimated that costs will be in the region of £10,000 per annum. This will be met from the Parking Account.

CONSULTATION

10. A formal consultation on the proposed Order was undertaken between 11 July 2018 and 3 August 2018 and in compliance with "The Local Authorities' Traffic Orders (Procedure) Scotland Regulations 1999 (and subsequent amendments)". Police Scotland, other emergency services and organisations/persons likely to be affected by any provision in the Order were notified of the proposals. Notices of the proposals were also published in the local 'Eastwood Extra' and 'Barrhead News' newspapers.

PARTNERSHIP WORKING

- 11. The Roads Service work in partnership with the Health and Social Care Partnership who receive, assess and determine all valid applications for Disabled Persons Parking Places.
- 12. The Roads Service work in partnership with the Corporate & Community Services in a joint working arrangement to undertake the Council's parking enforcement operations including the misuse of Disabled Persons Parking Spaces.

IMPLICATIONS OF THE PROPOSALS

- 13. Introduction of a new Traffic Regulation Order to enable enforcement of Disabled Person Parking Places not already covered by the current Order and also permit the removal of Disabled Person Parking Places covered by the current Order but which are no longer required.
- 14. There will be no property, IT, equalities or sustainability implications arising from the proposals. There is a positive equality outcome in relation to these proposals.

CONCLUSIONS

15. "The East Renfrewshire Council (Disabled Persons' Parking Places) (On-Street Parking) Order 2018", will help to prevent misuse of parking places designated for the exclusive use of Disabled Blue Badge holders. It is concluded that the Council should approve and authorise the making of the Order.

RECOMMENDATIONS

16. It is recommended that the Council approve the making of the East Renfrewshire Council (Disabled Persons' Parking Bays) (On-Street Parking) Order 2015 and delegate to the Director of Environment the implementation of the Order in accordance with the associated statutory procedures.

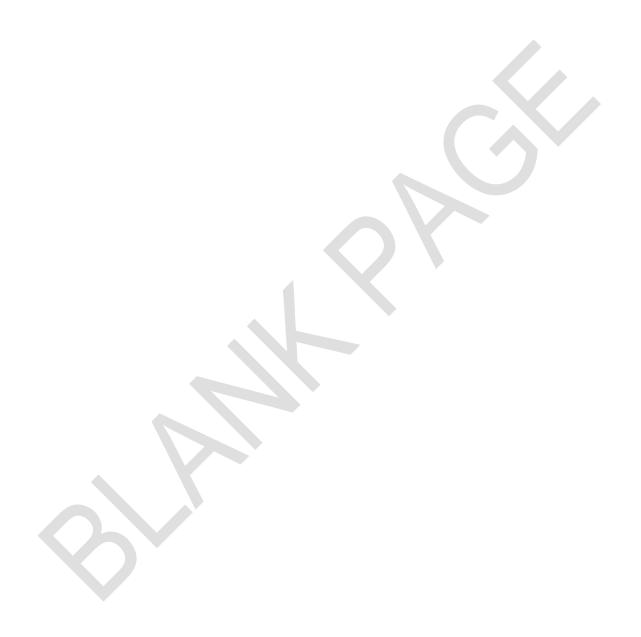

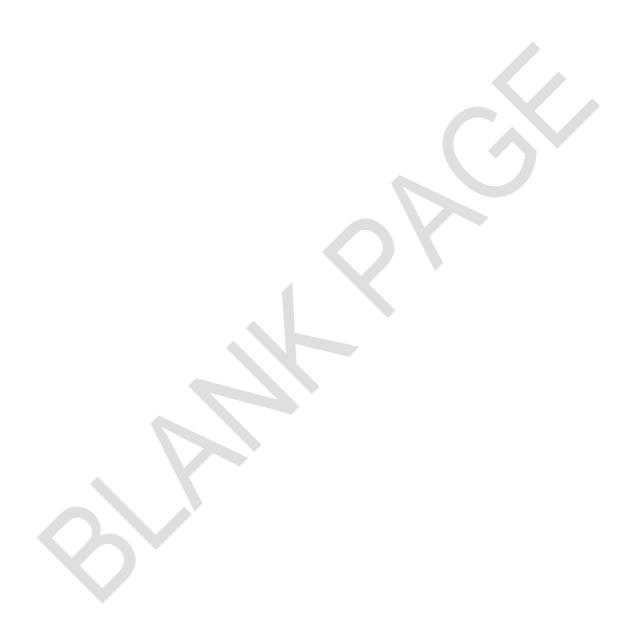

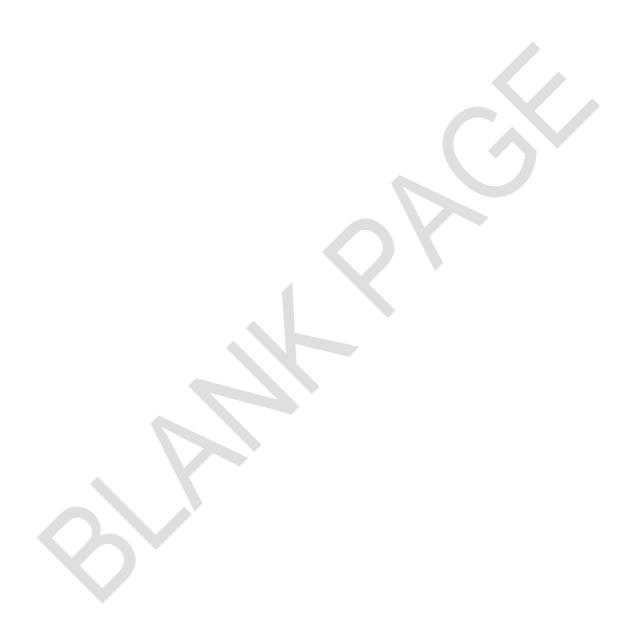

The East Renfrewshire Council in exercise of the powers conferred on them by Sections 45 and 46 and Schedule 9 of the Road Traffic Regulation Act 1984 ("The Act") and of all other enabling powers and after consultation with the Chief Constable of Police Scotland in accordance with Part III of Schedule 9 to the Act hereby makes the following Order.

- 1. This Order may be cited as "The East Renfrewshire Council Disabled Persons' Parking Place (On-Street Parking Order) 20[**]" and shall come into operation on **Insert DATE here**.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. In this Order the following expression have the meanings hereby assigned to them:-

"vehicle", unless the context otherwise requires, means a vehicle of any description and includes a machine or implement of any kind drawn or propelled along roads whether or not by mechanical power;

"disabled person's badge" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (Scotland) Regulations 2002;

"disabled person's vehicle" means a vehicle lawfully displaying a disabled person's badge in the relevant position;

"relevant position" has the same meaning as in Regulation 3 of the Local Authorities Traffic Orders (Exemptions for Disabled Person's) (Scotland) Regulations 2002;

"emergency service vehicle" means a vehicle being used by the police, fire brigade or ambulance services;

"local authority" means East Renfrewshire Council;

"Council" means the East Renfrewshire Council:

"parking place" means a space on land which forms part of a road which is intended for the leaving of a disabled person's vehicle and is marked or signed for use only by a disabled persons' vehicle;

"parking attendant" has the same meaning as in Section 63A of the Road Traffic Regulation Act 1984.

Note:

- (i) All words importing the singular also include the plural and vice versa where the context requires.
- (ii) Except where the context otherwise requires, references to any enactment include any such enactment as amended, extended or applied by or under any other enactment.
- (iii) All signs, carriageway markings etc. shall comply with the Traffic Signs Regulations and General Directions 2016.

Section 1: No Waiting Except for Vehicles Displaying a Disabled Persons' Badge

- 1/01 Each length of road described in Schedule 1 of this Order is hereby designated as a parking place.
 - (i) The parking places designated in this Order shall only be used for the leaving of a disabled persons' vehicle which is not causing an obstruction and which displays in the relevant position a disabled person's badge and for no other purpose. The parking places may be so used without charge.
 - (ii) No person shall cause or permit a vehicle to wait in the parking places designated in this Order unless the vehicle displays in the relevant position a valid disabled person's badge.
 - (ii) The limits of the parking place designated in this Order shall be indicated on the carriageway in such a manner as the local authority may determine by signs, carriageway markings, lines or other indications and shall comply with the "Traffic Signs Regulations and General Directions 2016"
 - (iii) Every vehicle left in a parking place designated in this Order shall so stand such that every part of the vehicle is within the limits of a parking place provided that where the length of a vehicle precludes compliance with this paragraph, such vehicle shall be deemed to be within the limits of a parking place bay if:-
 - (a) the extreme front portion or, as the case may be, the extreme rear portion of the vehicle is within 300 mm of an indication on the carriageway provided under this Order in relation to the parking place;

and

- (b) the vehicle or any part thereof, is not within the limits of any adjoining parking place.
- 1/02 Nothing in Article 1/01 of this Order shall:
 - (a) prevent any person from causing or permitting a vehicle to wait or load in any parking place designated in this Order:-
 - if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his/her control or to such waiting being necessary in order to avoid an accident;
- 1/02 Any persons duly authorised by the local authority, a traffic warden, a police officer or parking attendant in uniform may move or cause to be moved in case of an emergency, to any place they think fit, vehicles left in a parking place designated in this Order;
- 1/03 Any person duly authorised by the local authority may suspend the use of a parking place designated in this Order or any part thereof whenever such suspension is considered reasonably necessary:-

- (i) For the purpose of facilitating the movement of traffic or promoting safety;
- (ii) For the purpose of any building operation, demolition, or excavation in or adjacent to the parking place or the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any traffic sign, parking ticket machine, sewer or of any main, pipe, apparatus for the supply of gas, water or electricity or of any telecommunication apparatus;
- (iii) For the convenience of the occupiers of premises adjacent to the parking place on any occasion of the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository;
- (iv) For the convenience of the premises adjacent to the parking place at times of weddings or funerals or on other special occasions; or
- (v) On any occasion on which it is likely by reason of some special attraction that any street will be thronged or obstructed
- (vi) For any other purpose which the Council may from time to time see fit and which has received their prior approval.
- 1/04 Any person suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph 1/03 of this Article shall thereupon place or cause to be placed in or adjacent to any part of that parking place the use of which is suspended a traffic sign indicating that:
 - (i) waiting by vehicles is prohibited; or
 - (ii) limited waiting during prescribed hours is suspended; or
 - (iii) use as a disabled person's parking place is suspended.
- 1/05 No person shall cause or permit a vehicle to be left in any part of a parking place during such period as there is in or adjacent to that part of the parking place a traffic sign placed in pursuance of paragraph 1/04 (i) of this Article:- provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for fire brigade, ambulance or police emergency purposes to be left or any other vehicle to be so left if that vehicle is left with the permission of the Council suspending the use of the parking place or the part thereof in pursuance of paragraph 1/03 of this Article or of a police constable in uniform or a parking attendant in uniform.

Section 2: Orders Revoked

- 1/01 "The East Renfrewshire Council Disabled Persons' Parking (On-Street) Parking Order 2015" is hereby partially revoked as follows:
 - (i) Each length of road described in Schedule 2 of this Order is no longer designated as a parking place to be used only for the leaving of a disabled persons' vehicle.
