THE EAST RENFREWSHIRE COUNCIL (NEWTON MEARNS AREA – PHASE 1) (ON-STREET) (WAITING AND LOADING) ORDER 2018

PURPOSE OF REPORT

1. The purpose of the report is to recommend the Council approve the making and confirmation of "The East Renfrewshire Council (Newton Mearns Area – Phase 1) (On-Street) (Waiting and Loading) Order 2018".

RECOMMENDATIONS

2 It is recommended that the Council approve the making and confirmation of "The East Renfrewshire Council (Newton Mearns Area – Phase 1) (On-Street) (Waiting and Loading) Order 2018" and delegate to the Director of Environment the implementation of the Order in accordance with the associated statutory procedures.

BACKGROUND

3. The Council introduced Decriminalised Parking Enforcement (DPE) in April 2013 and became the Parking Authority for East Renfrewshire.

REPORT

- 4. A review of current restrictions was undertaken to assess the demands on the transport network taking into consideration changes to road layouts, increased volumes of vehicular and pedestrian traffic and associated road safety issues as a precursor to a formal consultation process and making of a new Order.
- 5. An informal consultation seeking feedback on suggested changes to existing restrictions was carried out from 17 April 2017 to 26 May 2017. Letters were sent to properties located directly adjacent to or within 50 metres of a proposed restriction advising of the consultation and where drawings showing the proposals could be viewed and where any representations or objections could be sent. Copies of the drawings were available for viewing at the Mearns Library and at the Council offices in Eastwood Park, Giffnock. Digital copies of the proposals were also made available on the Council's website. Over 70 responses were received with the vast majority of these in support of the restrictions proposed. In response to the representations received, several amendments were subsequently made to the initial proposals prior to the commencement of a formal consultation.
- 6. It was determined that restrictions in the Kirkhill area should be withdrawn from the proposals at this stage in the process to enable a full assessment of the locus to be carried out in collaboration between the Council's Transportation Section, Police Scotland and the Education Department following a recent road traffic incident involving a motor vehicle and a young pedestrian. Restriction proposals for the Kirkhill area will be presented at a later date in the 'Newton Mearns Area Phase 2' Order.

- 7. A formal consultation was carried out between 8 December 2017 and 3 February 2018 in compliance with "The Local Authorities' Traffic Orders (Procedure) Scotland Regulations 1999 (and subsequent amendments)". Letters were sent to 691 properties located directly adjacent to or within close proximity to a proposed restriction advising of the consultation, where drawings showing the proposals could be viewed and where any representations or objections could be sent. Police Scotland, emergency services and other organisations/persons likely to be affected by any provision in the order were notified individually of the proposals. Notices of the proposals were also published in the local 'Eastwood Extra' newspaper and on the Council's web site.
- 8. The key proposals in the Draft Order are summarised in the table in Appendix 1. The list is not comprehensive and the full proposals are contained within the Draft Order. Copies of the existing and Draft Orders are available in the Members' Library and on the Council Website. The main points of note are:-
 - Introduction of various waiting restrictions to address inconsiderate and dangerous parking around a number of schools,
 - Introduction of 'No Waiting at Any Time' restrictions at a number of road junctions,
 - Introduction of 'No Waiting at Any Time' restriction on a section of Capelrig Road close to the access to The Avenue shopping centre,
 - Introduction of waiting and loading restrictions in the vicinity of the Harvie Avenue shopping area,
 - Introduction of restrictions in various streets in close proximity to Whitecraigs Train Station.
 - Introduction of "No Waiting at Any Time" restrictions on sections of Fruin Avenue.
- 9. A total of 55 representations were received, 42 stated or implied an objection to one or more of the restrictions proposed and the remaining 13 were in support of the restrictions proposed. A reply acknowledging receipt of each representations received was issued. The majority of objections related to the proposed restrictions in The Loaning and the subsequent loss of parking space available for commuters using the Whitecraigs Train station. The restrictions for Maple Avenue also received a number of objections citing the loss of onstreet parking space for patients attending the health centre and dental surgery. A summary of all representations received, the response and proposed action to each is attached as Appendix 2.
- 10. In accordance with the statutory procedures, none of the objections require the Council to hold a Hearing by an Independent Reporter.

FINANCE AND EFFICIENCY

- 11. The financial implications of implementing the Traffic Regulation Order will be met from the Parking Account. This is an account held under the terms of the Road Traffic Regulation Act 1984 and it is a requirement under Section 55 of the Road Traffic Regulation Act that the Parking Account income and expenditure are reported annually to the Scottish Government.
- 12. There will be a requirement to renew/refresh lining and signing, update the Parking Attendants' hand held computers and carry out publicity. There will also be the normal maintenance costs associated with occasional lining and signing replacement which is estimated to be in the region of £3,000 every 8-10 years. All these requirements will be met from the Parking Account.

CONSULTATION

13. Consultation with regards to this Order was undertaken between 8 December 2017 and 3 February 2018 and was carried out in compliance with "The Local Authorities' Traffic Orders (Procedure) Scotland Regulations 1999 (and subsequent amendments)". Police Scotland, emergency services and other organisations/persons likely to be affected by any provision in the Order were notified individually of the proposals. Notices of the proposals were also published in the local 'Eastwood Extra' newspaper.

PARTNERSHIP WORKING

14. The Council's parking enforcement is a joint working arrangement between Roads & Transportation Services and Corporate & Community Services. The Service departments have worked closely on the preparation of the draft Traffic Regulation.

IMPLICATIONS OF THE PROPOSALS

- 15. Introduction of new & amended on-street waiting and loading restrictions in the Newton Mearns area.
- 16. There will be no property, IT, equalities or sustainability implications arising from the proposals.

CONCLUSIONS

17. "The East Renfrewshire Council (Newton Mearns Area – Phase 1) (On-Street) (Waiting and Loading) Order 2018", introducing new on-street waiting and loading restrictions in the Newton Mearns area, will balance the demands on the transport network taking into consideration changes to road usage, volumes of vehicular and pedestrian traffic and associated road safety issues.

RECOMMENDATIONS

18. It is recommended that the Council approve the making and confirmation of "The East Renfrewshire Council (Newton Mearns Area – Phase 1) (On-Street) (Waiting and Loading) Order 2018" and delegate to the Director of Environment the implementation of the Order in accordance with the associated statutory procedures.

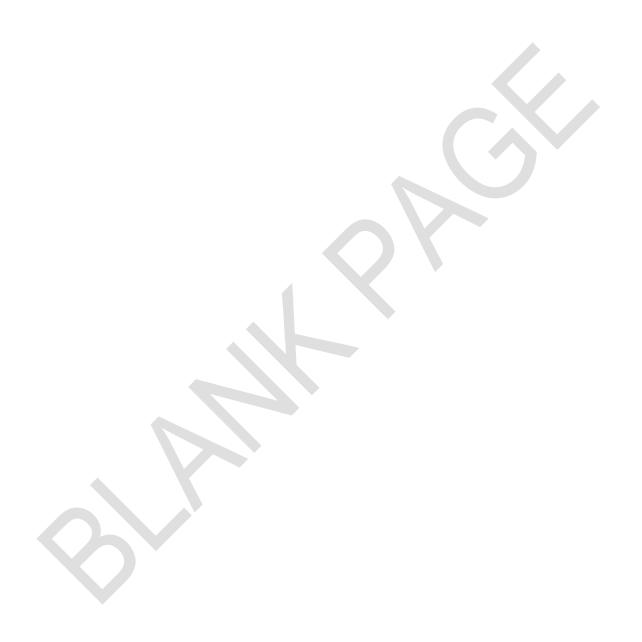
