Regional Planning

11. We are awaiting the updated regional report from the regional planning partnership and will share with the IJB when available.

Strategic Commissioning Plan

12. At the IJB seminar on 31 July 2018 it was agreed that the strategic commissioning intentions would be taken forward to consultation subject to a number of minor amendments. The consultation should set out the strategic context and challenges facing the HSCP. A range of accessible engagement materials will be developed during August and the consultation will begin in September.
