

CALENDAR OF MEETINGS

PURPOSE OF REPORT

1. To seek approval of proposed meetings dates for the Board for 2018.

3. At the meeting of the IJB in October 2016 meeting dates for the remaining meetings in 2017 were approved. The Board now needs to approve meeting dates for 2018.

4. It is proposed that meetings of the IJB be held on the following dates, continuing the arrangements for meetings to alternate between the HSCP Headquarters, Clarkston, and the Council Offices, Main Street, Barrhead:-

Wednesday 14 February (Barrhead) Wednesday 4 April (Clarkston) Wednesday 16 May (Barrhead) Wednesday 27 June (draft accounts)(Clarkston) Wednesday 15 August (Barrhead) Wednesday 26 September (including annual accounts)(Clarkston) Wednesday 28 November (Barrhead)

It should be noted that with regards to the meetings of 4 April, 27 June, 26 September and 28 November, subject to approval by the Performance and Audit Committee, arrangements will be made for the committee to meet prior to these meetings. In particular the meetings of the committee on 27 June and 26 September will meet to consider the draft and final annual accounts, prior to making a recommendation to the subsequent meetings of the Board.

6. To facilitate this, it is proposed to maintain the current arrangement that the meetings of the IJB being held on the above dates start at **10.30 am**. For the remaining dates on which there is no Performance and Audit Committee (14 February, 16 May and 15 August), the start time will stay at 10.00 am.
