MATTERS ARISING

PURPOSE OF REPORT

1. To update the Integration Joint Board on progress regarding matters arising from the discussion that took place at the meeting of 15 February 2017.

REPORT

Technology Enabled Care

Bonnyton House

4. The care home manager has established a group involving staff and trade union representatives to review staffing arrangements, including staff numbers and rotas. We will discuss planned changes with the Care Inspectorate to ensure compliance with their requirements.
5. Property and technical services are preparing quotes for refurbishment work to ensure the bedrooms previously used for respite are able to be used as permanent beds.
6. We are also exploring options to use some of these bedrooms as step down bed to allow for speedy discharge from hospital for East Renfrewshire residents who need short term intensive support to enable them to return to their own homes.
7. We are continuing to work with Grant Thornton to identify possible buyers and are looking to agree suitable timescales to remarket Bonnyton House.

Public Transport

8. The HSCP worked very closely with SPT to develop and pilot an additional bus service to the new Eastwood Health and Care Centre. The 375 bus service complements the hourly 374 bus service, which is a well-established route subsidised by SPT, including stops outside the new health and care centre. The 375 follows part of the route of the 374 including connection points for residents from further afield. Any extension to this service would impact on the half hourly timetable and would require 70 days' notice to the Office of the Traffic Commissioner, making it difficult for us to make any changes to this pilot. The passenger figures for the pilot 375 service are being monitored by SPT and the data gathered will be made available to bus operators on its conclusion to allow these companies to make an informed decision on the route's commercial viability.

9. Patients who have difficulty using public transport, can use the SPT operated 'MyBus' service which is a bookable bus servicing offering door-to-door transport, where possible. 'My Bus' can be used for GP appointments and will pick up and drop off as close as possible to the destination. All vehicles are low-floor and wheelchair friendly. Normal bus service fares apply and can be checked at the time of booking. National entitlement card, zone cards and day tickets are all valid. In addition, Community Transport East Renfrewshire operate "your wee red bus" which provides a service to medical appointments. Users need to be referred from their GP surgery.
10. Patient travel surveys are being developed and will be available at reception points throughout Eastwood Health and Care Centre.

Commissioning Intentions

11. A series of seminars will be organised and this will include an opportunity for further information to be provided on the Renfrewshire Development Programme.
