NOTICE OF REVIEW – REVIEW 2017/04 – ERECTION OF ONE AND A HALF STOREY REAR EXTENSION WITH RAISING OF RIDGE HEIGHT AND INSTALLATION OF DORMER WINDOWS AT FRONT, SIDES AND REAR AT 19 CAPLETHILL ROAD, BARRHEAD (REF NO: 2016/0735/TP)

2468. The Local Review Body considered a report by the Deputy Chief Executive, relative to a 'Notice of Review' submitted by Mr Sean Hogg against the decision taken by officers to refuse planning permission for the erection of a one and a half storey rear extension with raising of ridge height and installation of dormer windows at front, sides and rear at 19 Caplethill Road, Barrhead.

The decision had been made in accordance with the Council's Scheme of Delegation made in terms of Section 43A of the Town and Country Planning (Scotland) Act 1997 as amended.

In accordance with the decision taken at the meeting on 10 August 2016, the Local Review Body had carried out an unaccompanied site inspection of the application site immediately prior to the meeting.

The Local Review Body, having considered the information previously circulated, agreed that it had sufficient information to determine the review without further procedure.

Following discussion, it was agreed to uphold the decision as set out in the decision notice of 17 January 2017 and refuse planning permission.

NOTICE OF REVIEW - REVIEW 2017/05 - ERECTION OF ONE AND A HALF STOREY SIDE EXTENSION, ALTER HIPPED ROOF TO GABLE END AND INSTALL FRONT AND REAR DORMER WINDOWS AT 3 CRAIGIE DRIVE, NEWTON MEARNS (REF NO: 2016/0622/TP)

2469. The Local Review Body considered a report by the Deputy Chief Executive, relative to a 'Notice of Review' submitted by Mr M S Malik against the decision taken by officers to refuse planning permission in respect of the erection of a one and a half storey side extension, alter hipped roof to gable end and install front and rear dormer windows at 3 Craigie Drive, Newton Mearns.

The decision had been made in accordance with the Council's Scheme of Delegation made in terms of Section 43A of the Town and Country Planning (Scotland) Act 1997 as amended.

In accordance with the decision taken at the meeting on 10 August 2016, the Local Review Body had carried out an unaccompanied site inspection of the application site immediately prior to the meeting.

Having been advised that the applicant had submitted new evidence which was not before the Appointed Officer at the time the determination of the application was made and having noted the procedure that required to be followed should the new information be taken into account, the Local Review Body decided that the new information should be taken into account in the consideration of the review.

NOTICE OF REVIEW - REVIEW 2017/07 - ERECTION OF DETACHED GARAGE AT SIDE AND FORMATION OF GATES AND ASSOCIATED PILLARS FACING ONTO KENMURE ROAD AT 8 RODDINGHEAD ROAD, NEWTON MEARNS (REF NO: 2016/0747/TP)

2470. The Local Review Body considered a report by the Deputy Chief Executive, relative to a 'Notice of Review' submitted by Mr Andrew Samuel against the decision taken by officers to refuse planning permission in respect of the erection of a detached garage at side and formation of gates and associated pillars facing onto Kenmure Road at 8 Roddinghead Road, Newton Mearns.

The decision had been made in accordance with the Council's Scheme of Delegation made in terms of Section 43A of the Town and Country Planning (Scotland) Act 1997 as amended.
