4. POLICE REPORT

Police Report, due weather conditions and cancellation of BCC from 3rd March 2018, there are another 2 Community Council who have scheduled meetings on the 8th March 2018.

5. Civil Contingency

Mark introduced himself to the group; he gave an update on his background, they are also a partner agency in the annual Safety in the Park event with a scenario on Emergency grab bags, which should consists of Water, Energy Bar, Radio, Pen & Paper for use in a Safe House.

They work in 4 areas, Inverclyde, Renfrewshire, East Renfrewshire, & West Dumbarton.

Emergency events that could happen include:

- Weather floods, snow, storms ice or heat wave
- Industrial loss of power, heating or water; chemical or nuclear leak
- **Disease** pandemic flu or animal disease
- Transport accident road, rail, air or sea
- Public safety fire or terrorism

When an emergency occurs, the **emergency services are the first to deal with the situation**. Local authorities assist the emergency services in certain situations.

Every local authority has an emergency planning team who create and implement plans to prevent and respond to emergencies. Emergency planning aims to prevent emergencies from occurring, and if the emergencies do occur, implement plans to reduce and control the threats

.

There was also a discussion surround a road accident which happened at St Marks school because of all the irresponsible parking, this is not the first road accident to happen at St Marks Primary.

7.Matters Arising from previous minutes

A letter was send to the Chief Executive of East Renfrewshire Council with concerns about Cllr Aiken becoming a Independent Councillor, and despite the fact he has not been seen in Barrhead, Neilston or Uplawmoor, but recently seen in the Barrhead News raising concerns about Carlibar Bridge, despite emails & one formal invitations was sent to him inviting him to attend Barrhead Community Council in December 2017.

The written response was read out at the meeting, however Cllr Aiken refused to stand down, he is allowed to continue as an elected member representing the electorate of Barrhead, Liboside & Uplawmoor.

I also contacted MSP Jackson on the matter; his response was read out at the meeting.

ERC have bought back 22 ex council houses, however it has been stated recently that these houses had been bought back by ERC & BHA Further information was required.

Barrhead HA and ERC both had ROTS Programme (Rent of the Shelf properties) that was funded partly by the Scottish Government. BHA purchased 10 properties across Barrhead Centre ranging from Centenary Court, Gladstone Ave & Barnes st, ERC purchased the remainder.

Arthurlie Family Centre.

The Family Centre has been cleared by Education Department and is now vacant, however ERC have not declared it surplus and the building's future has not been fully decided.

Glen st Bridge repair.

The repairs were carried out by Roads. Scottish Power requires reconnecting diversion cables, once completed the permanent fencing will be installed, hopefully within 4/6 weeks this information was provided on 5th February 2018.
