1) MATTERS ARISING FROM THE MINUTES OF THE MEETING HELD ON 20TH NOVEMBER.

2) POLICE REPORT - 8th November to 7th January. P.C CANNON.

Housebreaking or other theft.

- On the 3rd into 4th November, a theft from an apparently insecure works van occurred in Easterton Avenue, Busby. This crime remains undetected at the time.
- A report was also received of a theft in another commercial vehicle overnight on the 27th into 28th November, from Glenville Gate, Busby. Enquiries are ongoing into this crime.

Antisocial behaviour and disorder.

- The vandalism to two cars have been reported in Lower Mill Road and Cartview Court. A report of graffiti was also received relating to premises in Church Road, Busby. A window of a dwelling flat in Mary Young Place was also smashed on the 22nd November.
- During the early evening on the 7th December a 39 year old female was arrested following a disturbance at a business premises in Helena Place Busby.
- About 4pm on the 15th December, a male youth smashed a window on St Josephs Primary School, Busby. Officers are following a positive line of enquiry in relation to this crime.

- Overnight on the same day, a vehicle parked on Birch Crescent, Busby was deliberately scratched. This crime is still under investigation.
- On 7th January 2 separate calls relating to youth disorder were received. Youths loitering in Riverside Gardens and Field Road respectively. Police attended both locations and no crimes were established.

Violent Crime.

- About 5pm on Thursday 7th December an assault and vandalism occurred at a licensed premise in Main Street, Busby. Two males, aged 18 and 19 years respectively, were traced and arrested, and were detained in custody to appear at Paisley Sherriff Court the following day.

Drug Dealing and Misuse.

- About 8pm on the 17th November, officers identified a 20 year old male in Field Road, Busby who was found to be in possession of a quantity of herbal cannabis.
- About 5pm on the 24th November officers had cause to speak to a driver in Bon Accord Road, Busby, at which time he was found to be in possession of a quantity of herbal cannabis.
