

**Minutes of the Meeting of Giffnock Community Council.**

**Venue: Giffnock Library**

**Date: Monday 15<sup>th</sup> January 2018 at 7.00 p.m.**

**Police report:**

Constable Ryan Cannon attended the meeting and provided a crime statistics report for the period 8<sup>th</sup> December 2017 to 7<sup>th</sup> January 2018, the contents of which were noted.

Further to the incidents of house breaking included in the report, it was reported that arrests of six people in Bellshill had recently been made, which were possibly connected to the spate of burglaries. This is part of a major and on-going police investigation.

An incident involving theft of a BMW at Braemar Court, Hazelden Gdns, Muirend in late December was not mentioned in the report – why was this? Possibly as this in the G44 postcode area, it is included in another area – Constable Cannon agreed to investigate. (This area is included in the Giffnock Community Council area.)

Vincent McCulloch asked if the police report for Giffnock could also be published by him on the ERC website – this was agreed.

**Approval of Minutes**

The minutes of the meeting on 18<sup>th</sup> December 2017 were presented for approval.

**Membership – Interim Election**

Vincent McCulloch advised that the interim election would be a 10 week process.

If the existing co-opted members were to resign and then apply to become fully elected members, this could give the community council more scope to co-opt further members. It was felt however, that doing this would not be of significant benefit to GCC.

Details of any people interested in applying should be passed to Vincent McCulloch so that he can send them the necessary documentation.

An application has been received from Richard Loudon to become an associate member of GCC. This application was proposed by JP and seconded by DL.

**Chair's Report**

DL has contacted Neighbourhood Watch to invite them to give a presentation at the next meeting on 20<sup>th</sup> February.

Vincent McCulloch stated that Neighbourhood Watch would be giving a presentation at the next Community Council Network Meeting on 31<sup>st</sup> January. This could possibly mean that GCC members would see the same presentation twice. It was decided however to proceed with the invitation.

**Secretary's Report**

Invitations have been received to attend:-

- The Community Council Network Meeting on 31<sup>st</sup> January – Bill Crawford and Janey Floyd have indicated their intention to attend; Jack Powell and Maureen Powell also likely to attend.

## **Matters arising from minutes**

### *Roads/Pavements – budget commitments*

JP referred to the draft report on the Budget Consultation meeting held in November. At this meeting strong representations were made by various community council members to maintain funding for improving/repairing roads. A suggestion had also been made to allocate £3 million from reserves to improving roads and pathways as it was felt this would lead to future economies on roads maintenance. Cllr Fletcher indicated that all submissions would be considered once ERC knows its budget allocation from the Scottish Government.

DL asked if the detailed results from the public consultation on road improvements could be made available. Cllr Gordon agreed to make enquiries.

### *Braidbar Quarry/Huntly Park*

No indication of any further developments.

### *Closure of Wholefoods.*

JP had written to Graham Shankland in Planning seeking clarification regarding the status of the former Wholefoods building in the Local Development Plan. In his reply Mr Shankland has indicated that the consents regarding housing development have now expired, and that “there is still a presumption in favour of retail use at this site.” However, no approach has so far been made from any retailer.

### *Community Hub Initiative – VAER, conversation meeting*

An email has been received from Ruth Gallagher of VAER indicating their intention to hold a community conversation meeting in the near future.

## **Planning**

MP reported that the BRGR application to open a hot food takeaway outlet in Station Road has been approved on appeal.

This, together with the recent approval of a restaurant with a takeaway outlet in the former Clydesdale Bank building, means that there will soon be four restaurants in close proximity, three with takeaway outlets in the centre of Giffnock. Concern was expressed, both personally, and reflecting reactions from friends and neighbours of GCC members, that this is an overprovision in such a confined area and that problems of parking, littering and loitering could possibly occur.

It was also felt that planning decisions are being taken out of local control and that local authorities and community councils are being sidelined. Further, the planning rules are not working well towards providing a balanced range of businesses in this area. It was agreed to write to Jackson Carlaw MSP expressing GCC's concerns regarding these issues.

## **AOCB**

*Refuse collections over the festive period* – DL reported that there appeared to be insufficient information about the bin collection arrangements over the festive period, resulting in people missing collections. Cllr Fletcher stated that information was available on the ERC website, but admitted that quite a lot of people seemed to have been caught out by the fact that the system for New Year was different from that of Christmas.
