#### **Introduction and Welcome**

Mr Daly welcomed everyone to the first meeting of the community council held under the amended Scheme of Establishment for Community Councils and following the recent election process. He explained that he was attending the meeting on behalf of the Returning Officer that he would conduct the initial part of the meeting up to and including the appointment of office bearers and would leave the meeting at that point.

#### **Declaration of the Result of Election**

Mr Daly explained that at the close of the nomination period, sufficient valid nominations had been received to allow the community council to be established but that as there were more places available than valid nominations received, all those persons who had submitted a valid nomination form were elected unopposed to the community council.

He then read out the list of those persons validly nominated which was noted by the community council.

#### **Declarations of Acceptance of Office**

Mr Daly explained that one of the requirements of the amended Scheme was that community council members sign an undertaking confirming that they would fulfil the duties of the role to the best of their ability and would undertake to meet the requirements of the amended Scheme, the model constitution and the code of conduct for community council members.

Completed forms were returned from those present.

# **Adoption of Model Constitution and Model Standing Orders**

Mr Daly explained that in the first instance it as necessary for the community council to agree to adopt both the model constitution and standing orders which formed appendices to the amended scheme. Mr Daly stated the Chairman could only serve from October 2015 to April or May 2016 and could not be re-elected in 2016. This statement was disputed by a number of people present including George McLachlan and Tracy-Jane McGinley (see clause 9.2). Mr Daly spoke of the ability of the community council to make a request to the council for the restrictions on the terms of office of the Chair to be lifted the community council agreed to adopt the Model Constitution and Model Standing Orders

### **Appointment of Chair**

Mr Daly called for nominations for the position of Chair.

Mr Smith, seconded by Mrs Baxter, proposed that Mr McLachlan be appointed Chair.

There be no further nominations, Mr McLachlan was appointed Chair of the community council.

### **Appointment of Secretary**

Mr Daly called for nominations for the position of Secretary.

Mrs Kennedy, seconded by Mrs McGinley, proposed that Mrs Baxter be appointed Secretary.

There be no further nominations, Mrs Baxter was appointed Secretary of the community council.

# **Appointment of Treasurer**

Mr Daly called for nominations for the position of Treasurer.

Mr McLachlan, seconded by Mrs Kennedy, proposed that Mrs McGinley be appointed Treasurer.

There be no further nominations, Mrs McGinley was appointed Treasurer of the community council.

Mr Daly left the meeting at this point.
