## **Keeping People Safe in East Renfrewshire**

#### Introduction



Welcome to the latest East Renfrewshire Local Police Plan update, covering the period July to September 2020. This is the second update in relation to our 2020-2023 Police Plan, which is now available on the Police Scotland website. As the Divisional Commander for Greater Glasgow, I am delighted to present this report and I am honoured to have been entrusted with building upon the good work of my predecessor Hazel Hendren.

The officers working within East Renfrewshire remain focussed upon the local policing priorities identified by our communities, however, since these priorities were agreed so much has changed. During this reporting period a significant amount of our time and effort has been directed at meeting the immediate challenges thrown up by COVID-19. Maintaining operational delivery during an unpredictable pandemic has been a challenge as the virus has taken its toll on our communities and indeed many of our own staff. We have adapted new ways of working and new ways of delivering our services and I am confident that, in spite of having to interpret and enforce some fairly intrusive legislation, we have maintained the confidence and support of our communities delivering the highest policing standards possible.

The pandemic has provided a challenging background, however, many aspects of policing have not changed. We have continued to deal robustly with criminality and have increased further our focus on protecting the vulnerable. This has of course been achieved through a partnership approach with many of them contributing to some of the good work outlined in this report. I am pleased to report that we have achieved some notable results and have delivered some significant improvements, a flavour of which will be covered in this report. Thank you sincerely for your continued support.

#### **Drug Dealing & Misuse**



Local Policing Priority: Crime (Drug Supply & Manufacture) Fairer East Ren Plan: Reducing social isolation, Ioneliness & increasing safety

Despite the pandemic, there has been continued proactivity in the first half of 2020/21 in relation to individuals involved in the supply of controlled drugs. The number of reports submitted to the Procurator Fiscal for persons involved in the supply, production and cultivation of drugs has increased from 9 to 14 compared to the same period last year. We have made several arrests and seized a variety of controlled drugs, including ecstasy and herbal cannabis.



first quarter where 8 serious assaults were reported. The crimes that are occurring are now happening in both indoor and outdoor settings as people are able to move about the area more freely.

The number of common assaults recorded is also lower with 211 crimes having been reported compared to 228 last year. Again, there has been a reduction in the number of the number of these crimes compared to the first quarter.

Detection rates for both common assaults and serious assaults have increased. 4 robberies were reported this year which is the same as last year, all of these crimes have been detected.

We remain committed to dealing quickly and effectively with incidents of domestic abuse. In the second quarter, the number of domestic abuse crimes increased from 155 to 172 and the number of domestic incidents attended has also increased from 259 last year to 275. Increased reporting is not unique to East Renfrewshire and similar trends have been seen in other areas. Local officers, along with our specialist Domestic Abuse Investigation Unit continue to pursue all investigative avenues in respect of these crime and provide support to victims.

#### **Public Protection**

#### Local Policing Priority: Crime (Sexual Offences)



The second guarter has seen a continued decrease in the reporting of sexual crimes with 51 victims having come forward compared to 74 last year. This reduction in the number of sexual crimes is welcome, however we continue to work with partner agencies to provide support to victims so they have the confidence to come forward and report ongoing and historical incidents.

#### **Acquisitive Crime**



The number of homes having being broken into is down to 34 compared to 42 last year.

This is also significantly lower than the 5 year average where there were 57 victims of domestic housebreaking.

#### Local Policing Priority: Crime (Crimes of Dishonesty) Fairer East Ren Plan: Reducing social isolation, loneliness & increasing safety

There have been 8 less victims of domestic housebreaking against last year's figures with 34 crimes being reported as opposed to 42 at the same point last year. This reduction follows the trend reported in the first quarter and may be partly due to people spending more time at home. Local protocols and support from the Division's Analysts ensure that any new patterns in this type of crime are quickly identified and officers are tasked to carry out additional patrols in any areas that are highlighted. Our officers continue to pursue all lines of enquiry and good forensic awareness has led to the apprehension of some prolific offenders.

Detecting those responsible for housebreaking can at times be difficult and protracted however, we continue to receive good support from local communities who report any suspicious activity they see.

Reducing anti-social behaviour remains a community priority and we continue to focus efforts on preventing disorder.

The increase in anti-social behaviour calls is mainly attributable to the additional 603 calls reported here previously for the first quarter. This means that the antisocial behaviour calls have vastly reduced compared to Q1 and are more in line with numbers normally reported. The additional 119 calls for quarter 2 reflects increased reporting to the Police in recent months.

As previously mentioned, reports of antisocial behaviour and disorder became more prevalent as 'lockdown' eased. As a result, we enhanced or sub-divisional disorder action plan with support from divisional and specialist resources. This plan focused on the parks and open spaces across the Local Authority, however we also ensured that our patrol plan included built up areas.

#### **CRIME**

#### Our Area of Focus: Violent Crime

Preventing violent crime remains at the forefront of everyday policing activity. As previously mentioned, detection rates have improved for robberies, serious assaults and common assaults. In July, officers responded after a female victim reported that she had been robbed of her personal belongings. Subsequent enquiries revealed that a 45 year female was responsible and a report was submitted to the Procurator Fiscal.

During another incident in August, a 34 year old male reported that he had been seriously assaulted in the Barrhead area. An investigation was undertaken by CID officers and a warrant was granted for the arrest of a 23 year old male in relation to the assault. This warrant was executed and the male is expected to appear at Paisley Sheriff Court in the near future.

#### Our Area of Focus: Drug Supply and Manufacture

During the second quarter, officers have continued to target individuals involved in the supply of controlled drugs.

In August, officers in the Barrhead area stopped a vehicle whilst on patrol. The driver was found to be under the influence of alcohol and during a subsequent search of his vehicle, a quantity of cocaine and ecstasy was recovered. He was detained in custody and appeared at Paisley Sheriff Court the following day.

In September, officers executed a search warrant at an address in the Barrhead area. A large quantity of herbal cannabis was recovered and several thousand pounds were seized under Proceeds of Crime legislation. A 28 year old male has been reported in relation to this.

#### Our Area of Focus: Crimes of Dishonesty

Human Rights In recent months, a number of elderly people were targeted by scammers and had money stolen from their bank accounts. Local Community Police Officers took on the enquiry and after a protracted investigation, they identified a 20 year old male as being responsible. He was charged with a total of 4 crimes and a case was submitted to the Procurator Fiscal. Follow up advice and support was given to the victims of all of these crimes.

CID officers also conducted an investigation in relation to a series of thefts in the area. Through diligent enquiry and capture of forensic and CCTV evidence, they identified two males, aged 34 and 35, as being responsible. They were reported for 7 crimes in East Renfrewshire and were linked with a number of similar crimes across the south side of Glasgow.

#### PROTECTING VULNERABLE PEOPLE

#### Our Area of Focus: Vulnerable Road Users

Positively influencing driver behaviour and improving road safety remains a local priority as identified by the residents of East Renfrewshire. Police officers have responded to community concerns about speeding vehicles and have carried out a number of checks across the area. This has resulted in 13 drivers being issued with a fixed penalty for driving in excess of the speed limit. 27 drivers were also reported for driving their vehicles without insurance.

Unfortunately our officers are still encountering individuals who drive their vehicles under the influence of alcohol or drugs. In September, a 41 year old male was arrested after a road crash. He failed the roadside breath test and it was also established that he had a provisional licence and did not have insurance for the vehicle. His vehicle was seized and a report was submitted.

In September, a 22 year old male was charged with dangerous driving. He had been travelling at excessive speeds in a built up area where he eventually crashed into a residential property causing damage to the structure. Again, a report was submitted.

#### Our Areas of Focus: Domestic Abuse— Adult Protection—Child Protection

Tackling domestic violence and ensuring that victims have the confidence to come forward remains a local and national priority. Our officers worked alongside colleagues from the Roads Department on a new initiative which developed road signs that encouraged victims to come forward and provided details of a helpline that they could phone. These signs were placed across the area and moved after a period of time to ensure maximum visibility. This joint initiative has received positive feedback.

**Greater Results In Partnership** 

The recently established Domestic Abuse Investigation Unit continue to deal with some of the highest risk cases in East Renfrewshire and support local officers with their investigations. One such investigation resulted in a repeat domestic offender being remanded in custody. Officers from the Unit have also provided a number of inputs to partner agencies about the work that they are carrying out.

#### Our Areas of Focus: Young People

As schools re-opened in August, our campus officers were again able to engage with young people across the area. They have provided inputs on a variety of topics including Firework safety and are now taking forward initiatives that they secured funding to support. These include working with an animal charity and establishing a coffee club within school. They also have a new road safety mascot 'Jackton' that they hope to introduce to children in the coming months.

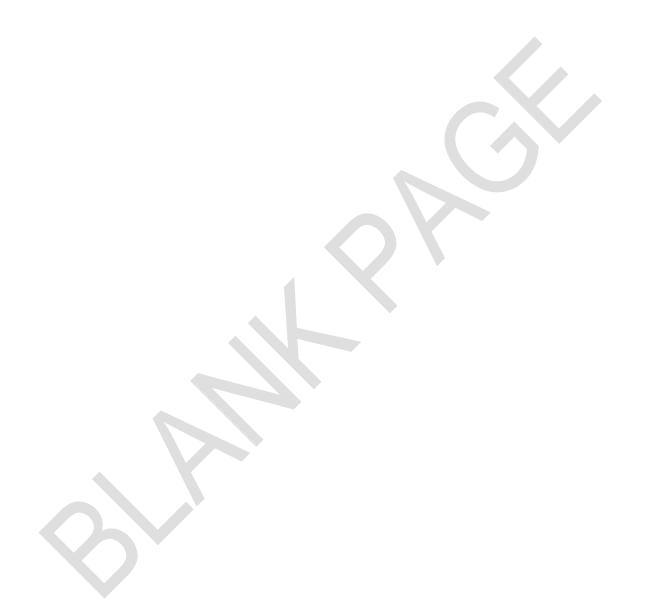

## Local Fire and Rescue Service Plan Priorities

The Local Fire and Rescue Service Plan has been developed to set out the priorities and objectives within East Renfrewshire and allows our local authority partners to scrutinise the performance outcomes of these priorities. We will continue to work closely with our partners in East Renfrewshire to ensure we are all "Working Together for a Safer Scotland" through targeting risks to our communities at a local level.

The plan has been developed to complement key partnership activity embedded across East Renfrewshire Community Plan and associated Delivery and Thematic plans. Through partnership working we will seek to deliver continuous improvement in our performance and effective service delivery in our area of operations.

The Local Fire and Rescue Plan for East Renfrewshire identified six areas for demand reduction and is subject to regular monitoring and reporting through the Police / Fire and Rescue Committee. A summary of the priorities and current activity is detailed below with further detail and analysis contained within this performance report.






#### **Activity by Time of Day**




#### Top 15 Incidents Types by %







## Domestic Safety - Accidental Dwelling Fires



Accidental Dwelling Fires (ADF) show a slight increase on both 'year on year' and '3-year average' indicators. Cooking remains the most common source of ignition, accounting for more than 60% the ADF's in East Renfrewshire. On all occasions smoke detection was fitted within the premises involved and in 88% of ADF's the detectors activated raising the alarm. 81% of the alarms raised via linked systems which means that SFRS are automatically responding to the premises on behalf of the occupier whether they have been alerted or not. This combination has provided early warning and intervention, which is reflected in the number of ADF casualties during this quarter.


## Domestic Safety - Accidental Dwelling Fire Casualties





#### **Accidental Dwelling Fires Casualties**




#### **Accidental Dwelling Fire Casualties by Ward (% share)**



#### **Nature of Injury**





#### **Extent of Harm**

























