If your event requires additional facilities or services such as vehicular access, extensive parking, erection of temporary structures such as gazebos etc., or is likely to impact land management operations or interfere with other visitor's use of the windfarm, it does not fall within the SOAC and you should contact the Countryside Rangers for further discussion and authorisation. If you can reduce/eliminate the use of any of these, your event will be much simpler to manage and will not require authorisation from land managers.

Please note that Whitelee cannot host any events that fall into the following categories:

- Fireworks displays / Bonfire events
- Balloon releases
- Kite, model aircraft, glider, hang-glider, parasailing, parachuting, hot-air ballooning (or any other 'flying' machine/apparatus) events
- Motorsport events
- Motorised water sports






