POLICE SCOTLAND GREATER GLASGOW DIVISION REPORT TO EAST RENFREWSHIRE CABINET POLICE PERFORMANCE OVER THE 3rd QUARTER OF FINANCIAL YEAR 2015/2016

Purpose of Report

The purpose of this report is to update members of East Renfrewshire Cabinet on police performance over the third quarter of the financial year 2015/2016. This narrative should be considered in conjunction with the accompanying Local Authority Scrutiny Board statistical report which is attached at Appendix 1.

Local Management

Chief Superintendent Andy Bates continues as Divisional Commander of Greater Glasgow Division. Chief Superintendent Bates has intimated that he is to retire from Police Scotland on 31 March 2016 and the process to identify his successor is currently ongoing.

Chief Inspector Angela Carty also continues as Area Commander of East Renfrewshire supported by Deputy Area Commander Inspector Alan Dickson. Sergeant Jim Boyle continues as Local Authority Liaison Officer.

East Renfrewshire Policing Plan 2014-2017

The priorities within the policing plan were identified through engagement and consultation across East Renfrewshire, this included our annual community consultation survey and regular consultation with elected members and other key partners. This consultation combined with crime and demand analysis informed the identification of the following priorities:

- 1. Tackling Violence, Disorder and Antisocial Behaviour
- 2. Protecting People
- 3. Increasing Public Confidence and Local Engagement
- 4. Tackling Serious Crime and Responding to Major Events.

SUMMARY OF PERFORMANCE FINANCIAL YEAR TO DATE 1 APRIL TO 31 DECEMBER 2015

EAST RENFREWSHIRE POLICING PLAN PRIORITY 1 - VIOLENCE, DISORDER AND ANTISOCIAL BEHAVIOUR

We continue to focus on preventing violence, disorder and antisocial behaviour. Our objectives included a commitment to:

- Reduce violent crime including alcohol related violence
- Increase detections of violent offenders including those who commit domestic abuse and hate crime
- Reduce the number of assaults
- Reduce the number of complaints regarding anti-social behaviour including disorderly conduct and drunk in public

Overall crimes of violence have remained the same as they did in this quarter last year. Of note there were 9 fewer victims of serious assault compared to the same period last year. Of continuing concern is the level of robberies in the area. During December 2015 we deployed our officers on a winter initiative, this was a high visibility patrol plan to prevent robberies both on the street and within premises where traditionally large sums of money are kept at that time of year. Our officers attended at vulnerable premises and gave safety advice and distributed leaflets on how to keep safe. We also contacted local press and were proactive in getting personal and business safety messages across. Significantly during the initiative there were no recorded robberies and this has continued into the New Year.

We have continued to maintain our focus on common assaults and 23 fewer assaults have been reported in comparison to the same period last year. Unfortunately the detection rate has also fallen on the same period last year, however at this time we have a number of assaults which are still under investigation and we would hope to have these detected within the next few weeks.

Increasing our detection rate for hate crimes continues to prove challenging. By the nature of the crime there are often no witnesses other than the victim themselves and often identification of the perpetrator is difficult. The detection rate is currently 71.8% and we continue to use all investigative techniques at our disposal. On a positive note there has been a 28.8% reduction in hate crimes reported to police.

Anti-social behaviour and disorder are often the precursor to crimes that affect quality of life and I am pleased to report that complaints regarding disorder have decreased by 8.3%. Incidents of vandalism and malicious mischief have decreased by 12.2% and the detection rate increased to 15.1%.

LOCAL POLICING PLAN PRIORITY 2 – PROTECTING PEOPLE

Keeping People Safe remains a priority for Police Scotland. Our objectives included a commitment to:

- Work with partner agencies to support victims of domestic abuse
- Work with partners and media to encourage people to report domestic abuse and sexual crime
- Reduce road deaths and serious injuries
- Reduce the number of housebreakings

We have remained focused on dealing quickly and effectively with domestic abuse incidents in East Renfrewshire and compared to the same period last year, the number of domestic abuse incidents has reduced. There has been a slight dip in the detection rate of domestic abuse incidents, however we continue to use every avenue of investigation to gather sufficient evidence to report perpetrators to the Procurator Fiscal. The year to date detection rate sits at 81.7%.

The Reactive Domestic Abuse Unit continues to work with our key partners and is co-located with Advocacy Support Safety and Information Services (ASSIST). A review of how we refer vulnerable victims of domestic abuse to ASSIST has ensured that victims get access to the right support, as soon as possible.

The National Disclosure Scheme for Domestic Abuse Scotland is operational in Greater Glasgow through positive interaction with partner agencies. This process allows us to share information about abusive partners past behaviour with potential victims, ensuring they have all the facts before deciding whether to continue with a relationship.

Tackling sexual crime and the sexual abuse and exploitation of children and vulnerable people remains a key priority for communities and for Police Scotland. Detection rates for crimes of indecency over the first nine months of the year are 80.6%, whilst 73.3% of reported rapes have been detected. The Division has experienced a 16.8% increase in reported sexual crime while East Renfrewshire has shown an increase of 39.6%. The increase demonstrates an improved confidence in the reporting of sexual crime as evidenced through the increase of historical reporting. The scheme between Police Scotland and Rape Crisis Scotland, offering 24 hour On-Call advocacy support to women and men reporting rape and other serious sexual crimes in Glasgow, continues to operate successfully.

The Public Protection Unit, in consultation with partner agencies, have implemented a formalised Initial Referral Discussion (IRD pilot) where there is an identified risk or potential risk of harm to a child. This process allows relevant partners to agree a set of actions which will be recorded on a single document. This can then be used by all partners to review progress towards our mutual objectives associated with child protection. This new process is a significant advancement and falls in line with previous recommendations

highlighted during multi-agency inspections and should improve our capability to keep young people safe.

Overall the numbers of houses and premises broken into has decreased by 20.9%, however disappointingly the detection rate has also decreased by 2.8% to 20.7%. We continue to use all investigative channels at our disposal to detect offenders, including fingerprinting and DNA. These processes can often take some time to produce results and a number of enquires remain open at this time.

LOCAL POLICING PLAN PRIORITY 3 – INCREASE PUBLIC CONFIDENCE AND LOCAL ENGAGEMENT

Objectives

To ensure that we maintain public confidence we are committed to listening to local people. Our objectives included a commitment to:-

- Publish updates outlining progress towards achieving the objectives outlined in the Multi Member Ward Policing Plans
- Report on performance measured against the local priorities identified by the public
- Maintain high levels of public confidence in policing
- Actively engage with local communities
- Maintain high standards of professional conduct

The updates for the Multi Member Ward Plans have been completed and are available on the Police Scotland Website www.scotland.police.uk.

A public consultation validation exercise was carried out in September. This was undertaken to ensure that we continue to focus on the issues that matter most to our communities. We are currently in the process of engaging various community groups, voluntary organisations, partner agencies and youth groups to name a few to inform future policing plans.

LOCAL POLICING PLAN PRIORITY 4 – TACKLING SERIOUS CRIME AND NATIONAL EVENTS

Tackling serious and organised crime remains one of our key priorities. Our objectives included a commitment to:

- Work with partners to deprive organised crime groups access to financial gains, achieved through legitimate enterprises
- Target organised crime groups through proceeds of crime legislation

Between April and December this year, 438 SAOC individuals were arrested and police activity in the Greater Glasgow Division alone has helped deprive

criminals of over £4,330,104 in cash and assets, seized under the Proceeds of Crime Act.

There have been a number of highlights between October and December 2015:

In recent months, officers from Greater Glasgow Division have worked closely with officers from Renfrewshire and Inverclyde Division (K Division) due to a crime group owning a company which consisted of a car wash, ice cream parlour / deli and spare tyres premises, located on an old petrol station in Renfrew. Along with Renfrewshire Council, Trading Standards, HMRC and Scottish Power, a number of days of actions took place resulting in a temporary closure. On 24 September 2015, Sherriff Officers attended along with Police and removed all persons and closed down all three premises indefinitely, returning control of the land to its owner.

On Friday 20 November 2015, officers from Greater Glasgow, led a second multi-agency day of action which took place across Police Scotland targeting five business premises linked to organised crime. This resulted in seven arrests for immigration offences. Many of the premises had to close temporarily due to staff being arrested.

Ongoing work by the Divisional Interventions Unit to identify legitimate companies using non Security Industry Authority (SIA) approved security companies linked to organised crime groups. Divisional Intervention Unit staff approach companies and provide them with advice guidance in respect of contract renewal and aim to deprive security companies linked to organised crime of these contracts. This work has been carried out in partnership with SIA and Her Majesties Revenue and Customs.

As a direct result of the actions taken by 'G' Division Interventions Unit Waitrose have now changed their contracts across the UK for all new builds and fit outs to state that any on site security must be from the SIA approved contractor list.

Drug production and supply continues to be a key concern for members of the public in Glasgow. We have been focusing on this issue and since April 2015 there have been 732 detections for such offences. A number of significant drug seizures have been made including the identification of several large scale cannabis cultivations.

Also all premises within the Division identified as selling psychoactive substances were visited by Police and partner agencies. Letters were issued to the shop owners advising of the dangers involved in selling the psychoactive substances.

We remain focused on reducing the availability of drugs in our communities and on acting robustly when information identifies such criminality.

Conclusion

As Local Police Commander I am pleased to present this policing plan update for the third quarter of 2015-2016. Overall crimes of violence have remained broadly the same compared to the same period last year with serious and common assaults showing significant decreases. Domestic abuse has shown a decrease in numbers of recorded crimes in East Renfrewshire and this is reflected across Greater Glasgow.

I am pleased to report that the detection rates for violence, serious assault, robbery and domestic abuse are all above 80%. We continue to tackle those issues that cause most concern to our local communities and continue to work closely with East Renfrewshire Council. As you are all aware this is my last report and I am pleased to be handing over a positive overall picture of crime levels in East Renfrewshire. I am sure my successor will continue to work closely with yourselves building on the strong relationship and joint working ethos which has seen crime in East Renfrewshire reduce by 37% in the last five years.
