THE EAST RENFREWSHIRE COUNCIL (THORNLIEBANK & WEST GIFFNOCK AREA) (ON-STREET) (WAITING AND LOADING) ORDER 2016

PURPOSE OF REPORT

1. The purpose of this report is to recommend the Council approve the making and confirmation of "The East Renfrewshire Council (Thornliebank & West Giffnock Area) (On-Street) (Waiting and Loading) Order 2016".

RECOMMENDATIONS

It is recommended that the Council approve the making and confirmation of "The East Renfrewshire Council (Thornliebank & West Giffnock Area) (On-Street) (Waiting and Loading) Order 2016" and delegate to the Director of Environment the implementation of the Order in accordance with the associated statutory procedures.

BACKGROUND

3. The Council introduced Decriminalised Parking Enforcement (DPE) in April 2013 and became the Parking Authority for East Renfrewshire.

REPORT

- 4. A review of current restrictions was undertaken in the Thornliebank/West Giffnock area to assess the demands on the transport network taking into consideration changes to road layouts, increased volumes of vehicular and pedestrian traffic and associated road safety issues as a precursor to a formal consultation process and making of a new Order.
- 5. An informal consultation seeking feedback on suggested changes to the restrictions was carried out from 16 February 2015 to 16 March 2015. Nearly 350 questionnaires were sent to frontagers directly affected by proposed changes and to properties within 50 metres of a proposed restriction. Notices advising of the proposals and viewing locations were posted in the local post office, medical centre, and other local community facilities. Exhibition boards showing the current and proposed restrictions along with paper questionnaires were put on public display in the Spiersbridge Council Offices. Digital copies of the proposals and questionnaire were also made available on the Council's website. A total of 23 responses were subsequently received with 21 of those coming from residents and the remaining 2 from unknown responders.
- 6. Many of the responses related to a proposal to introduce loading bays on Main Street, Thornliebank suggesting that there was no consensus or perceived demand for these. The other issues raised by respondents were varied and did not indicate a significant area of concern.

- 7. Following the informal consultation and the feedback received, a formal consultation was carried out from 12 September 2016 to 14 October 2016 in compliance with "The Local Authorities' Traffic Orders (Procedure) Scotland Regulations 1999 (and subsequent amendments)". Police Scotland, emergency services and other organisations/persons likely to be affected by any provision in the order were notified individually of the proposals. Notices of the proposals were also published in the local 'Eastwood Extra' newspaper and on the Council's web site.
- 8. The key proposals in the Draft Order are summarised in the table in Appendix 1. The list is not comprehensive and the full proposals are contained within the Draft Order. Copies of the existing and Draft Orders are available in the Members' Library and on the Council Website. The main points of note are:-
 - Limited waiting time of 30 minutes Monday to Saturday on sections of Main Street, Thornliebank fronting shops (No change to existing provision).
 - Introduction of 'No Waiting at Any Time' restrictions at a number of junctions.
 - Introduction of 'No Waiting at Any Time' restriction on a section of Inglestone Avenue, Thornliebank.
 - No specific On-Street Disabled Persons' Parking Bays are proposed due to existing exemptions from waiting restrictions already available to Blue Badge holders.
- A total of 6 formal objections and a further 4 representation were received in relation to the proposals. Replies acknowledging receipt of objections/representations were issued in all cases. Three objections received were from residents adjacent to restrictions proposed on Orchard Park Avenue at the junction with Main Street, Thornliebank citing the resultant loss of available on-street parking near their properties. These restrictions were consequently amended to take into account the residents' concerns. Two objections received were from residents in the vicinity of restrictions proposed at the junctions of Orchard Drive with Belmont Drive and Glenville Avenue; one citing the loss of available onstreet parking and the other citing potential increase of traffic speeds due to the removal of parked vehicles. The restrictions proposed at these locations are considered necessary to ensure the safe use of the junctions for all road users. The final objection was to a restriction proposed at the end of Lochiel Road adjacent to the footpath leading to the McDonalds Restaurant citing the loss of available on-street parking for residents. This proposed restriction was consequently withdrawn. Following the amendments made to the proposals, two of the objections received were formally withdrawn. A summary of all objections and the response or proposed action to each is attached as Appendix 2.
- 10. In accordance with the statutory procedures, none of the objections require the Council to hold a Hearing by an Independent Reporter.

FINANCE AND EFFICIENCY

- 11. The financial implications of implementing the Traffic Regulation Order will be met from the Parking Account. This is an account held under the terms of the Road Traffic Regulation Act 1984 and it is a requirement under Section 55 of the Road Traffic Regulation Act that the Parking Account income and expenditure are reported annually to the Scottish Government.
- 12. There will be a requirement to renew / refresh lining and signing, update the Parking Attendants' hand held computers and carry out publicity. There will also be the normal maintenance costs associated with occasional lining and signing replacement which is estimated to be in the region of £1500 every 8-10 years. All these requirements will be met from the Parking Account.

CONSULTATION

13. Consultation with regards to this Order was undertaken between 12 September 2016 and 14 October 2016 and was carried out in compliance with "The Local Authorities' Traffic Orders (Procedure) Scotland Regulations 1999 (and subsequent amendments)". Police Scotland, emergency services and other organisations / persons likely to be affected by any provision in the Order were notified individually of the proposals. Notices of the proposals were also published in the local 'Eastwood Extra' newspaper.

PARTNERSHIP WORKING

14. The Council's parking enforcement is a joint working arrangement between Roads & Transportation Services and Corporate & Community Services. The departments have worked closely on the preparation of the draft Traffic Regulation Order to ensure that the new restrictions can be readily enforced and incorporated into the work programme.

IMPLICATIONS OF THE PROPOSALS

- 15. Introduction of new & amended on-street waiting and loading restrictions in Thornliebank & West Giffnock Area.
- 16. There will be no property, IT, equalities or sustainability implications arising from the proposals.

CONCLUSIONS

17. "The East Renfrewshire Council (Thornliebank & West Giffnock Area) (On-Street) (Waiting and Loading) Order 2016", will introduce new on-street waiting and loading restrictions in Thornliebank & West Giffnock Area, and will balance the demands on the transport network taking into consideration changes to road usage and volumes of vehicular and pedestrian traffic and associated road safety issues.

RECOMMENDATIONS

18. It is recommended that the Council approve the making and confirmation of "The East Renfrewshire Council (Thornliebank & West Giffnock Area) (On-Street) (Waiting and Loading) Order 2016" and delegate to the Director of Environment the implementation of the Order in accordance with the associated statutory procedures.
