PURPOSE OF REPORT

REPORT

Bonnyton House

- 3. Since the last meeting, HSCP staff have had several planning meetings with Grant Thornton. They have finalised a marketing strategy and will advertise the sale of the care home in February with a closing date in April. HSCP managers will confirm an evaluation process to agree a purchaser by May/June.
- 4. We have kept the Care Inspectorate up to date on progress and ensured they understand the timescale we are working to. They have indicated it could take them up to 3 months to complete a change of registration to a new provider.
- 5. We have arranged two meetings on Tuesday 16th and Tuesday 23rd February to update residents' families on progress. We continue to update our staff following the 1 to 1 meetings we offered to each of them

Named Person

- 6. The Scottish Government launched the 'Consultation on Complaints Concerning Functions Relating to the Named Person and Child's Plan' in September 2015. This covered the powers of the Scottish Government to introduce a complaints procedure relating to the role of the Named Person and also in relation the Child's Plan of the Children and Young (People) Scotland Act 2014. It aimed to complement the consultation on the associated statutory guidance which can be viewed on the Scottish Government website here: http://www.gov.scot/Publications/2015/06/9933
- 7. The findings of the consultation have been analysed and a report published on 12 January 2016. It sets out how Scottish Ministers have considered the findings of the consultation exercise in producing the Order for Parliamentary consideration and also plans for developing and publishing guidance to accompany the Order. This will be discussed within the Children's Services Core to consider the implementation.

Winter Plan

- 8. Since the last meeting of the IJB the Winter Plan has been in place to ensure we are prepared to deal with any winter pressures that may arise. The report highlighted the actions we have taken in response to Scottish Government guidelines to support NHS Greater Glasgow and Clyde planning for the winter period.
- 9. A major focus has been on avoiding delayed discharges to prevent backlogs building up in the major hospitals. As we explained in the report, this work is linked to our broader strategic approach to avoid delays by focusing on 4 linked workstreams prevention and anticipatory care, point of possible admission, the admission process and discharged from hospital.
- 10. Our delayed discharge figures have remained very low. We usually have between 1 and 3 people in the system who are fit for discharge and delayed due to a range of factors. Our delays are generally very brief and our staff work hard to keep them to a minimum. Our figures are consistently the lowest across NHS GG&C and compare very favourably with the other similar sized HSCP's.
- 11. We have had no indication of increased demand during the winter period. We monitor demand in our services and link with GP practices to look for indications of any surge in demand. All services are busy but no seasonal increases in flu, respiratory conditions or other winter related illnesses have been confirmed.
- 12. Despite the difficult weather conditions since Christmas, there has been no issues for us in service delivery and increased demand
