TAXI DRIVER'S LICENCE - APPLICATION FOR GRANT

2274. The committee considered a report by the Chief Officer (Legal & Procurement) regarding an application for the grant of a Taxi Driver's Licence (Agenda Item 3 refers). The

applicant was present accompanied by his companion Mr Mackrell. Chief Inspector Carty and Sergeant Brown representing the Chief Constable, who had made an objection in respect of the application, were also present.

The report explained that in terms of the Rehabilitation of Offenders Act 1974 (Exclusions and Exceptions) (Scotland) Order 2003, applicants for Taxi and Private Hire Car Driver's Licences were required to disclose all previous convictions, both "spent" and "live". Details of the applicant's conviction were listed.

The report further explained that in determining the application it would be for the committee to decide what weight it wished to attach to the applicant's previous conviction, taking account of the period of time since the commission of the offence, its relevance to the type of licence being applied for, and also the objection by the Chief Constable.

The Civic Government Enforcement Officer was heard in respect of the report and in response to questions from Members.

Having heard the Chair express the committee's concern at the potential implications for public safety raised by the licence holder's action and warn him as to his future conduct, the committee agreed that the licence should not be suspended on this occasion.

WHEELCHAIR ACCESSIBLE VEHICLES AND TAXI LICENCE LIMIT

2281. Under reference to the Minute of the meeting of 16 August 2016 (Page 1990, Item 2128refers) when the committee had considered a report by the Chief Officer (Legal & Procurement), the committee considered a further report in relation to a proposed change of policy on the grant of taxi vehicle licences in East Renfrewshire and associated changes.

Having heard Councillor Reilly explain that he had received representations from East Renfrewshire Disability Action (ERDA) requesting further time to consider the implications of the report, the committee agreed to defer consideration to a future meeting of the committee.
