# NOTICE OF REVIEW - REVIEW 2016/13 - ERECTION OF TWO STOREY SIDE EXTENSION AT 14 HAZELDEN GARDENS, NETHERLEE (REF NO: 2016/0407/TP)

**2289.** The Local Review Body considered a report by the Deputy Chief Executive, relative to a 'Notice of Review' submitted by Mr and Mrs Tortolano against the decision taken by officers to refuse planning permission in respect of the erection of a two storey side extension at 14 Hazelden Gardens, Netherlee.

The decision had been made in accordance with the Council's Scheme of Delegation made in terms of Section 43A of the Town and Country Planning (Scotland) Act 1997 as amended.

In accordance with the decision taken at the meeting on 10 August 2016, the Local Review Body had carried out an unaccompanied site inspection of the application site immediately prior to the meeting.

The Local Review Body, having considered the information previously circulated, agreed that it had sufficient information to determine the review without further procedure.

Following discussion, it was agreed to uphold the decision as set out in the decision notice of 6 September 2016 and refuse planning permission.

NOTICE OF REVIEW - REVIEW 2016/14 - INSTALLATION OF MONO-PITCH ROOF OVER EXISTING EXTENSION AT REAR OF 27 DRUMBY CRESCENT, CLARKSTON (REF NO: 2016/0471/TP)

**2290.** The Local Review Body considered a report by the Deputy Chief Executive, relative to a 'Notice of Review' submitted by Mr Michael Byers against the decision taken by officers to refuse planning permission in respect of the installation of a mono-pitch roof over the existing extension at the rear at 27 Drumby Crescent, Clarkston.

The decision had been made in accordance with the Council's Scheme of Delegation made in terms of Section 43A of the Town and Country Planning (Scotland) Act 1997 as amended.

In accordance with the decision taken at the meeting on 10 August 2016, the Local Review Body had carried out an unaccompanied site inspection of the application site immediately prior to the meeting.

The Local Review Body, having considered the information previously circulated, agreed that it had sufficient information to determine the review without further procedure.
