#### PURPOSE OF REPORT

1. This report provides a detailed list of performance indicators and measures in line with Integration Scheme requirements

#### RECOMMENDATION

2. Committee is asked to note the content of this report

#### BACKGROUND

- 3. The Integration Scheme for the establishment of East Renfrewshire Health and Social Care Partnership sets out the arrangements for performance reporting as follows.
  - The Parties (East Renfrewshire Council and NHS Greater Glasgow and Clyde) will identify a core set of indicators that relate to Services from publicly accountable and national indicators and targets that the Parties currently report against. A list of indicators and measures which relate to integration functions will be collated along with information on the data gathering and reporting requirements for performance targets and improvement measures in a performance directory. The Parties will share all performance information, targets and indicators and the directory with the Integration Joint Board. The improvement measures will be a combination of existing and new measures that will allow assessment at local level. The performance targets and improvement measures will be linked to the national and local Outcomes to assess the timeframe and the scope of change.
  - The directory will also state where the responsibility for each measure lies, whether in full or in part. Where there is an ongoing requirement in respect of organisational accountability for a performance target for the Health Board or the Council this will be taken into account by the Integration Joint Board when preparing the Strategic Plan.
  - The directory will also be used to prepare a list of any targets, measures and arrangements which relate to functions of the Parties, which are not delegated to the Integration Joint Board, but which are affected by the performance and funding of integration functions and which are to be taken account of by the Integration Joint Board when preparing the Strategic Plan.
  - The directory will be reviewed regularly to ensure the improvement measures it contains continue to be relevant and reflective of the national and local Outcomes to which they are aligned.

- 4. As the Health and Social Care Partnership was established mid-year the agreement with the Parties was that for 2015/16 performance reporting for the HSCP would be on the measures and targets agreed with the former CHCP. This was reported through the Organisational Performance Report, which covered both the CHCP and HSCP performance from April 2015 until end of March 2016 in relation to commitments to East Renfrewshire's Outcome Delivery Plan and NHCGGC Local Delivery Plan.
- 5. The Integration Scheme contains a commitment that the Performance Data Directory will be reviewed regularly to ensure the improvement measures it contains continue to be relevant and reflective of the national and local Outcomes to which they are aligned
- 6. At its last meeting Performance and Audit Committee received a report on agreed performance measures for East Renfrewshire Health and Social Care Partnership. This set out the agreed national outcome indicators; development of East Renfrewshire Council performance measures as part of the Outcome Delivery Plan update and finalised list of measures agreed with NHSGGC.
