WRITE-OFF OF IRRECOVERABLE HOUSING BENEFIT OVERPAYMENT

PURPOSE OF REPORT

1. The purpose of this report is to seek approval to write-off as irrecoverable housing benefit overpayments up to the value of £122,110.03.

RECOMMENDATION

2. The Cabinet notes the report and approves the write-off sum up to the value of \pounds 122,110.03 of irrecoverable housing benefit overpayments. without prejudice to subsequent recovery procedure.

BACKGROUND

3. Housing benefit overpayments (HBOs) can occur where a housing benefit recipient fails to notify the Council of a change of circumstance which affects the level of housing benefit they are due to receive. In most cases this is due to oversight but in a small number of cases the overpayment is the result of an attempt to defraud. In higher value, more important cases of this type such action will lead to prosecution and in lower value cases to the addition of an administrative financial penalty. In almost all cases the recipient is expected to repay the resulting overpayment.

REPORT

4. Because in many cases HBO debtors' only source of income is benefits, housing benefit overpayments are very difficult to collect with only around 40% of overpayments being collected in the year in which they occur. Collection of fraudulent overpayments is prioritised over other overpayments. A period of prescription of five years is set for this type of debt which gives a very short timescale for Councils to take action to collects sums from debtors many of whom will continue to be in receipt of benefits or earn low incomes. Just over 30% of the sum recommended for write off is outwith the prescribed period.

5. A recent trawl of outstanding housing benefit overpayments shows by reason of write off.

6. In 2013/14 housing benefit overpayments totalled £283,237 and up to 31st December 2014, in the current year the value of overpayments is £264,309 of which the sum collected is £151,400 (57%). The sum recommended for write off represents around 43% of the 2013/14 overpayment level and can be met from existing bad debt provisions. The sharp increase in the value of write offs is because a full review of recoverability of outstanding overpayments has been undertaken following a recent Housing Benefit Risk Assessment which was undertaken by Audit Scotland.

RECOMMENDATION

7. The purpose of this report is to seek approval to write-off as irrecoverable housing benefit overpayments up to the value of £122,110.03.
