BURIAL GROUND CHARGES

PURPOSE OF REPORT

- 1. The Cabinet on 4th December 2014 agreed that a report on burial charges be submitted to the Cabinet meeting on 29th January 2015.
- 2. The report has been prepared after consideration of a benchmarking exercise with other local authorities to compare burial ground charges.

RECOMMENDATIONS

- 3. It is recommended that the Cabinet:
 - a) Approve a recommendation to increase cemetery burial charges to the levels specified in Appendix 1; and
 - b) Note the opening of the extended Muslim Section at Cathcart Cemetery shall increase burial income by approximately £46,800 per annum.

BACKGROUND

- 4. The Parks Service is responsible for the administration and maintenance of cemeteries (Cathcart, Eaglesham, Mearns and Neilston). As part of the Charging for Services process, a benchmarking exercise was undertaken to review charges in comparison to other Councils.
- 5. An extension to the Muslim Section at Cathcart Cemetery is scheduled for opening early in 2015 and approximately 750 additional lairs will become available.
- 6. To date, annual price increases for cemeteries lair purchase, burials and related activities have been made in line with corporate recommendations on Charging for Services rates. As a consequence, East Renfrewshire currently has a comparatively low charge for weekday burial under 'Resident' category. A 'Resident' is someone who either resides within East Renfrewshire or has lived within East Renfrewshire for a minimum of 50 years before moving out of the area. All other persons are classed as 'Non Resident'.
- 7. Lair purchase and burials charges were used as the main aspect of the Cemetery Service for seeking realistic benchmarking comparison with other local authorities. Appendix 1 illustrates the table of charges for the 25 Councils surveyed. Whilst many Councils have at some stage in recent years increased charges beyond inflation, East Renfrewshire has not.
- 8. 'Resident' lair purchase and subsequent burial is £715 as compared to £1168 which is the average of the other Councils surveyed (Appendix 2).

REPORT

- 9. As part of the Council's Charging for Services Review, an in depth study showed that, between 2010 and 2013, the number of burials dropped from 293 to 187 per annum. This was mainly attributable to capacity being reached at the Muslim section at Cathcart Cemetery. With the introduction of a new Muslim burial section at Cathcart Cemetery from early 2015, the number of interments is envisaged to rise to approximately 250 per annum. A cost appraisal, based on the Parks Cemetery budget, is shown in Appendix 3.
- 10. The proposed charges would result in a continuing subsidy of the service, but with the envisaged increase in burials, income generation will rise and close the gap towards a break even position. A Weekend Standby Burial Service cost has also been evaluated and included as part of the scenario plan.
- 11. It is recommended that the cost of changes to the use of the burial service be met by increasing burial charges generally by 20%. In reference to the benchmarking exercise, the aforementioned increased charges shall not significantly affect the Council's position in terms of offering competitive burial charges and the Council would be 43% cheaper than the average of the other Councils surveyed.
- 12. The additional income generated for the Council as part of the scenario planning exercise is approximately £27.5k arising from increased charges and £46.8k from increased numbers of interments at Cathcart Cemetery (£69.8k of this sum is committed by the Parks Service as part of the budget reduction exercise).

FINANCE AND EFFICIENCY

13. There will be no further additional costs associated with the revised pricing structure, which will be implemented from 1st April 2015. The majority of added operational costs through increased numbers of interments shall be met by the Parks Service through allocation of resources between interments and cemetery ground-care duties.

CONSULTATION

14. Discussions have been held with the Finance Service.

PARTNERSHIP WORKING

15. There has been no necessity for partnership working as the purpose of the Cabinet report is to review burial charges and this has been based upon a benchmarking comparison with other Scottish local authorities' charges.

IMPLICATIONS OF THE PROPOSALS

- 16. There are no implications associated with this report in terms of property, legal, IT or equalities.
- 17. These changes will have no full time staff implications.

CONCLUSIONS

- 18. Implementing a more representative set of cemetery charges shall generate additional income and allow the Parks Service to achieve budget savings targets.
- 19. The proposal shall not reduce the effectiveness of service provision in an area that requires good customer care and sensitivity in all aspects of cemetery operations.

RECOMMENDATIONS

- 20. It is recommended that the Cabinet:
 - a) Approve a recommendation to increase cemetery burial charges to the levels specified in Appendix 1; and
 - b) Note the opening of the extended Muslim Section at Cathcart Cemetery shall increase burial income by approximately £46,800 per annum.

NOTES

- 1. The standard burial charge will be reduced by 50% for children 18 and under, with the exception of burials at weekends and on public holidays.
- 2. There will be no charge for burial of stillborn babies for residents of East Renfrewshire
- 3. The Non-Resident burial charge will be reduced by 50% for stillborn or children 18 and under, with the exception of weekends and public holidays.
- 4. Double Interment, second and subsequent coffins or cremated remains 50% of appropriate fee.
- 5. When a deceased person residing out-with East Renfrewshire has previously resided within the Council area for a minimum of 50 years, the surcharge for burial of non-Resident will not be applied.
