REQUEST FOR CIVIC HOSPITALITY PRESENTATION OF QUEEN'S AWARD FOR VOLUNARY SERVICE

PURPOSE OF REPORT

1. To homologate the decision made by the Head of Democratic and Partnership Services, in liaison with the Provost, to grant authority for the Council to host a civic reception at which the Queen's Award for Voluntary Service (QAVS) will be presented to East Renfrewshire Warriors by HM Lord-Lieutenant for Renfrewshire.

RECOMMENDATION

2. That the committee homologates the decision made.

BACKGROUND

3. On 26 June 2013, the Council agreed to establish a Civic Hospitality Committee with the following terms of reference:-

To be responsible for all civic hospitality matters on behalf of the Council including the:-

- consideration and determination of all requests for the provision of civic hospitality by the Council with an estimated cost of over £400;
- consideration and determination of any proposed new Council events to be funded from the civic hospitality budget; and
- consideration and approval of all protocols and procedures associated with civic hospitality.

REPORT

4. A request to hold a civic reception at which the QAVS would be presented to East Renfrewshire Warriors, which provides clubs and events for children with additional support needs in East Renfrewshire, was received from HM Lord-Lieutenant for Renfrewshire which, if approved, would cost more than £400. In view of this the request required to be considered by the committee. The details of the request are included in the accompanying appendix.

BUDGET

- 5. The 2015/16 budget for civic hospitality is £22,000. As well as being used to fund events organised in response to external requests for civic hospitality, the decision was taken that those annual events organised by the Council such as the Holocaust event, Remembrance, and the Senior Citizens' Concerts, are to be funded from this budget. Examples of other things also funded from this budget are the costs of attendance at any charity events such as the Fire Service Benevolent Fund Dinner, the costs associated with school debates, and the purchase of flowers for those known to be celebrating a special wedding anniversary or birthday (e.g. 100th birthday, diamond wedding anniversary etc.).
- 6. When the costs of these and related matters are taken into account the amount of funding remaining in the 2015/16 budget to deal with new requests for civic hospitality is currently estimated to be £6,479.
- 7. A meeting of the committee convened on 26 August to consider the request was inquorate. In view of this, to allow arrangements to be progressed, the Head of Democratic and Partnership Services, in liaison with the Provost, granted authority for the Council to host a civic reception on 1 October at which the QAVS will be presented by the Lord-Lieutenant for Renfrewshire. This report seeks homologation of that decision.

RECOMMENDATION

8. That the committee homologates the decision made.
