#### **DECLARATIONS OF INTEREST**

**1189.** There were no declarations of interest intimated.

SECTION 207 OF THE TOWN AND COUNTRY PLANNING (SCOTLAND) ACTS - PROMOTION OF A STOPPING UP ORDER - GREENLAW WAY, NEWTON MEARNS (REF NO: 2014/0270/TP)

**1190.** The committee considered a report by the Director of Environment, seeking authority to commence the promotion of a Stopping Up Order at Greenlaw Way, Newton Mearns (Ref No: 2014/0270/TP) in accordance with the terms of Section 207 of the Town and Country Planning (Scotland) Act 1997.

The report provided details about the application for planning permission (Ref No: 2014/0270/TP), which related to a residential development forming part of the Greenlaw Business Park and highlighted that it was considered necessary to promote a Stopping Up Order to enable the development to be carried out in accordance with the terms of the planning permission. It was noted that the Stopping Up Order required to be advertised for a 28 day period and that third parties or consultees would be given an opportunity to make representation thereon. Furthermore, should a representation not be withdrawn or capable of being addressed by means of an amendment to the Order, the matter would be referred to the Scottish Ministers who might hold an inquiry to resolve the matter.

The committee agreed to:-

- (a) authorise the commencement of the Stopping Up process as detailed in the report; and
- (b) otherwise note the contents of the report.
