PURPOSE OF REPORT

1. To update the Integration Joint Board (IJB) on matters of significant interest.

3. Grant Thornton have now completed their options review which considered the Council's proposal to sell the service and the subsequent proposals put forward by residents, families and staff to retain the care home under council management.
4. The recommendation made by Grant Thornton confirms that the alternative options put forward will not come close to delivering the level of savings required by the Council. The Review has concluded that the sale of the service is the only viable option.
5. A full report on the outcome of the options review will be taken to IJB in October 2015, when the review will be considered in full and a final decision will be made on the future of the Care Home.
6. The management team met with staff and trade union representatives on 23 July to discuss the recommendation. Two further meetings have been arranged for 24 and 28 August to give all Bonnyton staff an opportunity to meet to discuss the matter and ask any questions.
7. Letters have been sent to residents' families/carers and afternoon and evening meetings arranged for 6 August to provide support and information as we wait for a final decision to be made. Meetings with day service users' and their families/carers have been arranged for 17 August.
