<b>Extent and medium</b>	volumes, loose papers, maps and plans. 17 linear metres.
<b>Name of creator</b>	Burgh of Barrhead
<b>Administrative/ biographical history</b>	Barrhead was erected as a Police Burgh in 1894. It was succeeded by Renfrew District and by Strathclyde Region in 1974, and by East Renfrewshire in 1996.
<b>Archival history</b>	<p>The records of the Burgh were largely in situ when surveyed by the Scottish Record Office in c. 1969.</p> <p>After the 1974 local government reorganisation, it appears that several series were transferred from the Burgh Chambers to Paisley Museum where they were housed at Whitehagh Barracks. Others were held by successor departments at various Council offices; yet others by local libraries.</p> <p>Some time after 1996 some of the records were transferred to East Renfrewshire Council's Libraries Local Studies Section and held at "the Bothy" in Eastwood Park and at the Neilston Leisure Centre.</p>

<b>Scope and content</b>	<p>The Burgh Minutes (1/01) are complete, except for part of the year 1902. The first four volumes are hand-written, but there is a gap prior to the first printed and signed volume.</p> <p>Minutes of the Licensing Court (1/02) are extant only for 1964 to 1980.</p> <p>The Dean of Guild registers(1/03) are extant only for 1897 - 1923 and the Register of Major Warrants from 1964 - 1975 (see below, under Section 4, for other Dean of Guild Court Records).</p> <p>There is a short series of published Burgh handbooks (1/04).</p> <p>Subject files and other papers are available on: Housing (1/05); Parks (1/06); Roads and Streets (1/07) and sewerage (1/08).</p> <p>Burgh byelaws are listed at 1/09 and there are several (incomplete) series of letter books, both of letters in and copy letters out, covering the period from 1893 to 1913, listed at 1/10. 1/10/1 are the letter books of John Brownlie (Solicitor at Barrhead);</p>

and it is not at all clear that these are indeed Burgh records. 1/10/2 may in fact be two distinct series; there seems to be some confusion in their original order.

Police Court records are listed at 1/11 - mostly cases from 1966 - 1970.

There are also extensive miscellaneous and general files and papers (1/12) dating from 1893 to 1975.

Abstracts of Account (B 2/1) are extant only from 1946 onwards (although earlier accounts are endorsed with the minutes).

Assessment Rolls (B 2/2) are extant from 1949 - 1950 to 1969 - 1970.

There are also cash books (B 2/3), ledgers (B2/4), accepted offers for work (B2/5) and various other minor financial records.

The Surveyor's records comprise three folders of correspondence from 1958 - 1964 (B 3/1)

The Dean of Guild Court plans are extant from 1895. The earlier records are largely complete but later in the series there are numerous omissions. This series is somewhat disordered and several records not originally part of the series of D of G plans had been included in the prior listing. This content and order has been retained in the present listing.

### ***Appraisal, destruction and scheduling information***

Several triplicate volumes of minutes were identified. The 3rd copy in each case was not retained. The large quantity of boxed subject files in Accession 2009/ 08 were not all retained. This accession also comprised letter books from the mid 1960's to 1975. These were in poor physical condition and were unindexed, so we were not retained.

### ***Accruals***

It is likely that further Burgh material will emerge from within ERC.
